Shri Kanwar Lai Gupta: What are the charges? (Interruptions). I thought he would place it on the Table.

Fast by Labour Leader at Bhilai Steel Plant

- SNQ. 4. Shrimati Agam Das Guru Minimata: Will the Minister of Steel, Mines and Metals be pleased to state:
- (a) whether Government are aware that a labour leader in Bhilai Steel Plant has gone on fast unto death which has created a serious situation in Bhilai:
- (b) whether the cause of the fast is the failure of his Ministry to fulfil the assurances given by it to the labourers:
- (c) the details of the assurances given to the labourers; and
- (d) the steps taken so far to end the fast being observed by the labour leader and whether any talks in this regard have been held with the concerned parties so far?

The Minister of Steel, Mines and Metals (Dr. Chenna Reddy): (a) It is presumed that the Member is referring to the fast undertaken by a follower of the Chatisgarh Mazdoor Kalyan Sabha. The fast was called off on 25th May, 1967.

(b) and (c). During my visit to Bhilai on 18th May, 1967, the representatives of the Chhatisgarh Mazdoor Kalyan Sabha presented a Memorandum of demands in regard to the grant of employment and other facilities for Chhatisgarhies in the Bhilai Steel Plant. I indicated to them that within the framework of the recruitment policy of Hindustan Steel Limited, due consideration would be given to the sons of the soil in the matter of employment and other facilities.

(d) Does not arise, since fast has been called off.

श्रीमती प्रगम दास गुरु मिनीमाता : भिलाई मनदर सघ ग्रार मैनजमेंट के सामने क्या ग्रापने यह ग्राण्वामन दिया था कि दो मी में कम बेनन पाने वाले कर्मचारियों की भरती स्थानीय लोगों में से ही की जाएगी ?

भी बन्ता रेडडी : जो प्रतस्कित्य जानज दों सी रुपये में कम की होती है, उन में छत्तीमगढ के गरीब लोगों को लगाने के बारे में नहबाह देने ग्रीर बाग नार पर जिन की अमीने फैक्ट्री के लिए लीगई हैं उनके मालिकों के लड़कों बगरह को तस्बीह देने का ग्राण्यामन दिया गया था।

भीनती प्रमम दास गुरु निनीवाता : क्या धापने यह धाण्वासन भी दिया था कि छटनी किए गए छतीसगढ के मजदूरों को फिर से काम पर ले लिया जाएगा ?

भी चन्ना रेडी: टेम्पोरेरी नेवर के जो कार्य है, बंस्ट्रकशन का जो काम है उन में काम करने वालों की जो छंटनी की गई है उनको परमानेंट जाबज जैसे जसे आती जाएंगी, उन में उनको वापिस लेने के आदेश दियं गयं कोई और इस तरह की वैकेसीज धाएंगी उन में उनको वापिम लेन का आदेश दिया गया है।

श्रीमती प्रगम दास गृद मिनीमाता : मजदूर नेताओं की क्या यह भी एक मांग नहीं थी कि उनके एक मजदूर नेगा को मिलंक्यन कंपरी में सदस्य बनाया जाए श्रोरक्यायहमचनही है कि मंत्री गरी ने इसका भी ग्राप्यासन दिया था ?

श्री बन्ना रेडडी: जहा तक मिलवणन कमेटी का सम्बन्ध है, उस में लोकल गम्पलाय-मेंट एक्सचेंज का एक सदस्य रहता है ग्रोर नंबर की नरफ स कोई नमाइदा नही रहता

Shri J. B. Kripalani: May I know something which I do not understand. The Minister talked of 'sons of soil'. What is the meaning of 'sons of soil'? I thought in India there was only one soil. Are there many soils in India?

Dr. Chenna Reddy: I am sorry if any misunderstanding has been created. It was only the local people that were meant by that term.

Shri J. B. Kripalani: But he made a distinction between the local people and those in the rest of India. I think that it is against the Constitution to talk in those terms. We are all citizens of India and we can move about throughout the country.

श्री मृत्यंश्रय प्रसाव : मैं जानना चाहता हं कि यह प्राक्तासन क्या जिलाई के लिए ही है या दूसरे प्रान्तों में इस तरह की जो फन्हीज हैं या दूसरे सरकारी, दफ्तर निगम या कारखाने हैं उन पर भी यह लाग होता है ? इस माम्बासन पर कहां तक धमल होता है क्या इसका भी विचार किया जाता है, क्या इसको भी देखा जाता है यह नहीं ?

भी चभा रेड्डी: यह पब्लिक सैक्टर की तमाम भागनाइजेनंज में तमाम हिन्दु-स्तान में लागू होता है और इस उसूल पर अमल किया जा रहा है । जा अनिस्कल्ड लेडर है, जो गरीब लोग वहां के होते हैं, यह कहा गया है कि उनको तरजीह दी जाए ।

Shri S. M. Banerjee: May I know whether it has been brought to the notice of the hon. Minister that while this land was being acquired in Chatisgarh for the Bhilai steel plant a definite assurance was given to them that those people whose lands would be acquired and were acquired and their sons, would be given chances for employment in the Bhilai steel plant, and if so, whether that has been fulfilled or not?

Dr. Chenna Reddy: That kind uf assurance was really given and that is being taken care of. During my last visit, these points were raised, and the labour leader was requested to give a list of the names of persons who were still unemployed in this context so that the factory management could immediately find them suitable employment.

Shri S. Randappan: With regard to the retrenched employees of the Bhilai steel plant, they have been promised employment in future, but the promise has not been fully met. Even in those cases where a few of them have got employment again, there is a break in service and there is no continuity of service. I would like to know whether any thought has been given to this matter.

Dr. Cheana Reddy: The position as stated by the hon. Member is not basically correct. All such people have been paid compensation for the land and such people are also given employment. But since the labour leader mentioned that there were some more cases, I said that we would examine them also and we would take them. Besides these, there are

some people employed in construction works which are of a temporary nature. Even those people will be given preference in the matter of recruitment to the permanent cadre.

Shri S. Kandappan: My question has not been answered.

Shri Sezhiyan: What about the continuity of service?

Shri S. Kandappan: Even in those cases where they have got employment again, there is break of service and there is no continuity with the result that they lose their seniority.

Dr. Chenna Reddy: It all depends upon the circumstances of the service. If such cases are brought to the notice of the management, they can be examined.

Shri S. Kandappan: On a point of order. That had been stated here previously on the floor of the House. Simply because there is a change of Ministers, they should not come and say anything that they like. Are there different policies for different Ministers? I think the Government is the same.

Dr. Chenna Reddy: There is no question of change of policy. The same policy is being pursued since 1960 when a note had been circulated to all the public sector companies.

भी भाग रेड्डी: मुझ से मजदूरों के प्रत्या प्रत्या दलों के नेता जरूर मिले में । उन्होंने कई बीजों की मांग की थी भीर मेमोरेंडम भी दियं थे । उनकी जांच पडनाल हो रही है।

Mr. Speaker: Now, Shri S. M. Banerjec.

Conversions in Bihar

189. Shri Baburao Patel: Will the Minister of Home Affairs be pleased to state:

- (a) whether it is true that over 2,000 Christian missionaries have rushed to Bihar to take advantage of the famine conditions and carry out mass conversions of the famine-stricken people tempting them with food packets, clothes and money supplied by foreign Governments:
- (b) whether Government are aware that the Catholic Relief Services, a missionary organization, are actually feeding 409,000 famine-stricken persons with American help and has tied Christian religious medals and crosses around the necks of the famished people apparently for the purpose of identification, telling them that as long as they keep the medals round their esche and worship Jesus Christ, they will never have famine again;

- (c) whether the Catholic Relief Services have also been given foodgrains by Government for distribution among the famine-stricken people;
- (d) the steps taken by the Government to see that the present distress of the people of Bihar is not misused for the purposes of mass conversions by the Christian missionaries; and
- (e) the number of foreign volunteer organisations and the names of the countries from which they come, working in Bihar at present among the famine-stricken population?

The Minister of State in the Ministry of Home Affairs (Shri Vidhya Charan Shukia): (a) While a large number of Christian missionaries, both Indian and foreign, are engaged in relief work in different parts of Bihar, information as regards the exact number who have gone to Bihar from elsewhere is not available. There have been reports of conversions in some individual cases but not on a mass scale.

- (b) The total number of persons who are being fed in organised kitchens is about 4,76,000 and the Catholic Relief Services is only one of the twenty-six Indian and foreign relief organisations who are running these kitchens. There is no information to confirm what is stated in the latter part.
 - (c) No. Sir.
- (d) Government are fully aware of the situation and suitable action will be taken if and when necessary.
- (e) The information is being collected and will be laid on the Table of the House.
