में जो प्राईमरी और बेसिक ऐजूकेशन के सम्बन्ध की योजनाएं हैं उन की ओर सरकारों का ध्यान दिलाया है। विशेषतः में आनरेबिल मैम्बर का ध्यान स्कीम नम्बर १ की बोर दिलाना चाहता हूं जिसमें यह तमाम योजनायें शामिल हैं और जिस सम्बन्ध में केन्द्रीय सरकार ने स्टेट सरकारों को पार साल सहायता दी है।

Shri T. S. A. Chettiar: Out of these Rs. 198 crores allotted for the coming year, how much is proposed to be spent for basic education?

Shri K. D. Malaviya: That is a question which is under consideration. But last year about Rs. 33 lakhs was given to the State Governments.

Shri T. S. A. Chettiar: Out of this fund, how much is proposed to be spent through the States, and how much by the Government of India directly?

Shri K. D. Malaviya: Out of the total five year expenditure of Rs. 1.98 crores, it is proposed that the Government of India will spend Rs. 33 crores.

श्री एम॰ एल॰ ढ़िबेदी: जो पत्र व्यवहार राज्यों से सरकार ने किया है उस सम्बन्ध में क्या मैं यह जान सकता हूं कि इस धोजना को लागू करने में कितना समय लगेगा और केन्द्र की तरफ़ से इस में कितना धन व्यय किया जा रहा है?

श्री के ॰ डी॰ मालवीय: केन्द्र की तरफ़ से जो घन व्यय किया जा रहा है उस को तो में ने अभी बताया। लेकिन यह जो पंच की वर्षीय योजना है और बेसिक ऐजूकेशन जो योजना है उस सम्बन्ध में में माननीय सदस्य को बतलाना चाहता हूं कि यह एकदम से नतीजा नहीं दिखा सकती और बहुत जल्द इनका कोई परिणाम नहीं देखा जा सकता है। धीरें घीरे जैसे जैसे यहां उपयुक्त वातावरण बनता जायगा उसी हिसाब से यह योजनाएं आगे बहेंगी। डा॰ सुरेश चन्द्र: क्या में माननीय मंत्री से पूछ सकता हूं कि यह जो योजना है क्या इस को गवर्नमेंट ने पूरी तरह से स्वीकार कर लिया है या अभी तक इस को सिफ़्रं ऐक्सपैरीमेंटल स्ट्रेज़ पर ही रखा गया है?

श्री के ॰ डी ॰ मालवीय : इस समय तो गवर्नमेंट ने स्वीकार कर के ही योजना चालू की है और इस की सूचना भी स्टेट गवर्नमेंटों को दे दी है। जैसा कि मान गिय सदस्य को मालम होगा इसके लिए क्षेत्रों का चुनाव का आधार उसी प्रकार का है जैसा कि कम्यूनिटी प्राजैक्ट का आधार प्लानिंग कमीशन की योजनाओं में माना गया है।

Shri S. N Das: In view of the fact that the productive aspect of basic education has now been accepted, may I know whether the Government of India propose to take up the work of investigation of the obstacles in the way of the full development of the productive capacity of basic education?

Shri K. D. Malaviya: Yes, Sir. That question will be considered.

श्री एम० एल० डिवेबी: शिक्षा के सम्बन्ध में में एक बात और पूछना चाहता हूं और वह यह है कि क्या इस शिक्षा का प्रारम्म केवल प्राइमरी शिक्षा तक ही बेस्ड रहेगा या इस को और आगे स्कूल और कालेज में भी चलाया जायगा? इस सम्बन्ध में अगर सरकार ने कोई रूप-रेला बनाई हो तो वह बताने की कृपा करें।

श्री के बी॰ मालवीय: जैसा में ने अभी कहा, यह शुरू से आखिर तक की शिक्षा में लागू होगी। पोस्ट ग्रैजूएट ट्रेनिंग तक इस शिक्षा का आयोजन किया गया है।

Kazaks

*1094. Sardar Hukam Singh: (a\s^{\dots}\)
Will the Minister of Home Affairs be pleased to state whether the Kazaks (about 400 in number) who arrived on

the Leh border as displaced persons and were put in camps in the Kashmir State during 1951-52 to remain there till the circumstances became favourable for their departure, have gone back?

(b) If not, are they still in camps?

The Deputy Minister of Home Affairs (Shri' Datar): (a) and (b). 375 Kazak refugees entered the State in the year 1951, out of whom 25 have died, 172 have left for Turkey and 6 for Mecca. The rest viz., 172 are still in the State—168 in Srinagar and 4 in Ladakh.

Sardar Hukam Singh: Have any of them entered any other part of our country as well?

Shri Datar: No, they have not been sent to any other part

Sardar Hukam Singh: Were there any Chinese refugees, who came along with these Kazaks?

Shri Datar: No. Sir; to our information, only these people have come.

Sardar Hukam Singh: Have the Government of India incurred any expenses on account of their entry and maintenance here?

Shri Datar: All the expenses are incurred only by the Government of India.

Sardar Hukam Singh: What was the amount that has been incurred?

Shri Datar: The total amount spent till now is Rs. 42.820-4-9.

Shri T. K. Chaudhuri: May I know from which state they came?

Shri Datar: They came from Tibet.

Shri N. Sreekantan Nair: Have the Government of India ascertained the opinion of the Government of the U.S.S.R. or China in connection with the protection of these people?

Shri Datar: I did not follow the question, Sir.

Mr. Deputy-Speaker: Have the Government of India consulted or taken the opinion of the U.S.S.R. or Chinese Govérnment, in regard to these people?

Shri Datar: We have not taken the opinion of any of them. These people are political refugees, and so they have been given shelter here.

Sardar Hukam Singh: Are these people here because they were not

allowed into any other country, or is it because of some unwillingness on their part to move out of India?

Shri Datar: No, Sir. The difficulty of finding out sheter for them was there, and ultimately some shelter was found in Turkey for some, and for some in Mecca. Therefore they have gone. So far as the others are concerned, steps are being taken to send them to other countries as far as possible.
