(b) when the final report of the Committee is expected to be published?

The Minister of Education and Natural Resources and Scientific Research (Maulana Azad): (a) The members of the Committee visited some of the housing colonies in Delhi, including the labour Housing Colony under construction in Industrial area. The Secretary of Committee also visited the Central Building Research Institute, Roorkee; the Forest Research Institute and Colleges, Dehra Dun and important centres of industry to study various experiments in housing technique and methods followed in different parts of the country.

(b) It can be laid on the Table of the House if so desired by the House.

IRANIAN SOCIETY AT CALCUTTA

The Minister of Education and Natural Resources and Scientific Research (Maulana Azad): (a) None.

REMITTANCES TO PAKISTAN

- *1331. Shri Gidwani: (a) Will the Minister of Finance be pleased to state whether it is a fact that the Reserve Bank of India has registered a case under Section 5 of the Foreign Exchange Control Act against some Indian firms for unauthorised remittances to Pakistan in contravention of Exchange regulation?
- (b) What is the number of such firms and the places in which those firms are working?

(c) What was the amount involved in the said unauthorised remittances to Pakistan?

The Minister of Finance (Shri C. D. Deshmukh): (a) The Reserve Bank of India have not registered any case under Section 5 of the Foreign Exchange Regulation Act, 1947 against Indian firms for unauthorised remittances to Pakistan. but a case has been registered under that section in respect of payments in Indian currency made by a firm in India on behalf of persons resident in Pakistan. The Reserve Bank are also making enquiries into other unauthorised payment of a similar type made by persons and firms resident in India.

- (b) The number of such firms and persons involved is 12 with business at Bombay, Delhi, Amritsar and Ambala
- (c) The amount of unauthorised payments made in India on behalf of residents in Pakistan as disclosed by the enquiry so far made by the Reserve Bank comes to about Rs. 2 lakhs.

REGISTER OF ENGINEERS

*1331-A. Shri M. S. Gurupadaswamy: Will the Minister of Education be pleased to state whether Government propose to have a Register of Engineers, who are properly qualified and experienced in Engineering in all its branches?

The Minister of Education and Natural Resources and Scientific Research (Maulana Azad): A Register of Engineers is being compiled by the Council of Scientific and Industrial Research but the registration is on a voluntary basis. In so far as the question of compulsory registration of Engineers by a statutory body is concerned, the matter is under consideration.

*1332. Shri Brohmo-Choudhury: Will the Minister of Home Affairs be pleased to state how many officers from each State. State-wise, are serving (i) in the Tribal Welfare Branch of the
