## LIGHT-HOUSES

- \*2156. Dr. Ram Subhag Singh: Will the Minister of Transport be pleased to state:
- (a) whether Government to construct some new light-houses in India; and
- (b) if so, how many and at what cost?

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shahnawaz Khan); (a) and (b). Yes. The Development Plan on which the Central Lighthouse Department is working envisages the construction of about 100 aids to navigation at a total estimated cost of about Rs. 4 crores. A statement showing the works included in this Plan is laid on the Table of the House. [See Appendix IX, annexure No. 19.]

It is expected that out of these, works costing about Rs. 2 crores will be completed during the Five Year Plan period.

Dr. Ram Subhag Singh: May I know how many of the proposed light houses, estimates for which have been given in the statement, are proposed to be constructed during this year?

Shri Shahnawaz Khan: In the list about 100 aids to navigation have been mentioned. The complete list is on the Table of the House.

Mr. Speaker: He wants to know how many of these are likely to be completed during the course of the year 1954-55.

Shri Alagesan: It is a long list.

Mr. Speaker: The hon. Minister is not able to give them.

FLOOD RELIEF WORKS IN MANIPUR

- \*2158. Shri Rishang Keishing: Will the Minister of Food and Agriculture be pleased to state:
- (a) whether it is a fact that Government have sanctioned Rs. 1,48,000

- to Manipur for relief works in areas affected by heavy floods last year;
- (b) the number of people affected by the floods;
- Government have. (c) whether relief drawn up any scheme of works; and
  - (d) if so, the details thereof?

The Minister of Agriculture '(Dr. P. S. Deshmukh): (a) Yes.

- (b) Nearly 30,000.
- (c) Yes.
- (d) A statement indicating relief works proposed to be taken up during 1954-55 is placed on the Table of the House. [See Appendix IX, annexure No. 20.]

Shri Rishang Keishing: May I know if any Relief Work Committee has been formed by the public and if so, whether Government has consulted that Committee in drafting these schemes?

Dr. P. S. Deshmukh: I require notice.

Shri Rishang Keishing: Do Government propose to finish the execution of schemes before the next season sets in?

Dr. P. S. Deshmukh: The provision made is for the year 1954-55 and I think it is reasonable to expect that it will be spent during the course of the year.

Shri Rishang Keishing: Apart from the various schemes mentioned in the statement, may I know if Government is contemplating to undertake some permanent measures to control floods in Manipur?

Dr. P. S. Deshmukh: I do not see that there is any proposal of that nature for the moment before the Government.

## B. C. G. VACCINATION

\*2159. Dr. Natabar Pandey: the Minister of Health be pleased to state how many people were B.C.G. vaccinated in 1953 in Orissa?

The Deputy Minister of Health (Shrimati Chandrasckhar): 63,691 persons were B.C.G. vaccinated in Orissa in 1953.

Dr. Natabar Pandey: May I know whether any special arrangements have been made to get people B.C.G. vaccinated in the T.B. Sanitorium in Kalahandi District?

Shrimati Chandrasckhar: In the State of Orissa B.C.G. vaccination was introduced only in October 1953. I have already given the number. That is all that I can say about the number of persons B.C.G. vaccinated and tuberculin tested.

Dr. Natabar Pandey: Can the figures in regard to the State district-wise be given?

Shrimati Chandrasekhar: I have not got the break-up of figures.

Pandit D. N. Tiwary: In view of the increasing incidence of T.B. in the country, how long will it take for the Government to vaccinate the entire population with B.C.G.?

Shrimati Chandrasekhar: I would require notice.

JAPANESE METHOD OF RICE CULTIVATION

\*2160. Shri Sanganna: Will the Minister of Food and Agriculture be pleased to state:

- (a) whether all the State Governments have been asked to intensify the Japanese method of paddy cultivation during the next season; and
- (b) the acreage of land expected to be brought under cultivation thereby?

The Minister of Agriculture (Dr. P. S. Deshmukh): (a) Yes, Sir.

(b) A statement indicating the targets fixed for each State for 1954 is placed on the Table of the House. [See Appendix IX, annexure No. 21.]

Shri Sanganna: May I know whether it is intended to bring the entire country under the Japanese method of cultivation?

Dr. P. S. Deshmukh: That would not be very easy and may create problems of surplus and aggravate the present situation. Government have no present intention of doing that.

Shri Bhagwat Jha Azad: Since the Government is boosting up this Japanese method, may I know what would be the increase in yield per acre if the same amount is spent on boosting up the Indian type of cultivation?

**Dr. P. S. Deshmukh:** The increase in the yield would be negligible as against the yield by the Japanese method of cultivation which is phenominal.

Shri N. L. Joshi: May I know in which of the States the area under Japanese cultivation was the largest in the year 1953?

Dr. P. S. Deshmukh: I have not got the figures; but, from memory, I think West Bengal and Hyderabad were the States with the largest area.
