TOBACCO

- *1043. Shri Amjad Ali: Will the Minister of Commerce and Industry be pleased to state:
- (a) the variety and value of tobacco exported to Japan, United Kingdom and China during the period October 1954 to December, 1954;
- (b) whether the export is on the increase as compared to figures of period July to September, 1954; and
- (c) what steps, if any, have been taken to increase the export?

The Minister of Commerce (Shri Karmarkar): (a) to (c). A statement giving the information required is placed on the Table of the House. [See Appendix VI, annexure No. 35.]

Shri Amjad Ali: The Minister of Agriculture stated the other day that there is progressive decrease in the acreage of tobacco cultivation in India. In view of this, may I know how these propaganda measures are going to help the export trade?

Shri Karmarkar: About tobacco cultivation, I may refer the hon. Member to the Minister of Agriculture. If there is any question arising out of this question on tobacco, I shall be very happy to answer.

Shri Amjad Ali: Will the hon, Minister of Agriculture enlighten us on that point?

Shri Karmarkar: I have referred the hon. Member to the Minister of Agriculture for light on the tobacco cultivation as such.

Shri Amjad Ali: Whether it has affected the export trade—that is what I wanted to know.

Shri Karmarkar: Logically, no; because nothing can be exported unless it is produced. If it is a question of export, he might ask a question.

Shri K. K. Basu: May I know whether this decrease in the acreage of tobacco cultivation will adversely affect the export trade so far astobacco is concerned?

Shri Karmarkar: Obviously, if there is no production, there is no export. If there is a little production, there is a little export.
