### Re MOTIONS FOR ADJOURNMENT

Mr. Speaker: I have received notices of several adjournment motions. There is one thing that I want to make clear and I require the approval of the House in that. I desire that a convention might be established henceforward that no adjournment motion might be moved today when we hear the Address of the President. I will consider these adjournment motions tomorrow and take them up. They would not suffer on account of any delay or notice having not been given at the earliest opportunity. I will waive that. ### PRESIDENT'S ADDRESS

Secretary: Sir, I beg to lay on the Table a copy of the President's Address to both Houses of Parliament assembled together on the 18th April, 1962.

President's Address

संसद् के सदस्यण,

आपने गणराज्य के तीसरे संसद्-भवितव्यान के उद्घाटन के प्रवास पर, संसद् के सदस्यों के रूप में आपका स्वागत करते हुए मुझे बहुत खुशी हो रही है। आप में से बहुत से ऐसे हैं जो गत बवाँ में भी संसद् के सदस्य रहे हैं और जिन्हें एक बार फिर उनके निर्वाचिकों

ने चुन कर उनमें अपना विश्वास प्रगट किया है। आप में ऐसे लोग भी शामिल हैं जो सार्वजनिक कार्य के लिये या शायद विद्वान् सभाओं के लिए भी, नये नहीं, किन्तु जिन्हें संसद् के लिए पहली बार चुना गया है।

२. मैं आप सब को बधाई देता हूं और अपनी मत्तूभूमि की सेवार्थ सामूहिक प्रयत्नों के लिये आपका स्वागत करता हूं। संसद् की सदस्यता की अवधि में आप में से प्रत्येक को, संसद् के अन्दर अथवा अपने अपने चुनाव लोगों में अपने देश की सेवा के रचनात्मक कार्य के लिये अनिवार्य रूप से संगठित अनेक और व्यापक अवसर मिलेंगे। राष्ट्रीय निर्माण के कार्य की दिन प्रतिदिन की और अन्तिम जिम्मेदारी संसद् की है। इस कार्य के लिये आपकी पूर्ण विचारशक्ति, विश्लेषण, रचनात्मक आत्मचुना, सावधानी और समर्पण की क्षमता अवैक्षित है।

३. करीब एक महीना हुआ मैंने दूसरी संसद् के अन्तिम सत्र के सम्मुख अभिभाषण दिया और उसके बिंदु नीचे। राष्ट्रीय जीवन में हमारे प्रवक्तनों के कलस्वरूप विभिन्न लोगों में जो उमस्ति हो रही है, उसका मैंने उस समय संकेत में व्यूहा दिया था। तब से आज दिन तक, जब भुजे आपका स्वागत करने का श्रेय मिल रहा है, इस अल्प अवधि में भी कई दिशाओं में हमारा देश आगे बढ़ा है।

४. हमारे जौतिक विकास और वेणवाम सामाजिक तथा आर्थिक सन्तुलन को बनाये रखने का आधार हमारी योजनाबद् अर्थव्यवस्था है। तीसरी पंचवर्षीय योजना अपने दूसरे साल में है और इसका आरम्भ अच्छा हुआ है। इस व्यापक प्रयास का अभिप्राय है हमारी राष्ट्रीय अर्थव्यवस्था का निर्माण, उत्पादन और रोजगार में बृद्धि करना और अपने संविधान के आवेदानसार रासायनिक, आर्थिक और राजनीतिक व्याप के आकार वर समाज का गठन करना। यह प्राथमिक है कि

इस योजना के कार्यरूप में परिषत् होते हुए हमें उत्पादन के काम में अपने लोगों का बदावर बढ़ती हुई संस्था में सहयोग प्राप्त होता रहे और इस सहयोग का रूप दक्षता और जनता द्वारा हमारे राष्ट्रीय लक्ष्य को हृदयंगम करना हो।

५. देहाती क्षेत्रों में जनशक्ति का उपयोग करने के लिए कुछ समय हुआ प्रयोगात्मक योजनायें चली थीं और देहात विकास का यह कार्य बढ़ावा जा रहा है और अब इस अन्तर्गत २०० विकास केन्द्र आते हैं। यहां और घरेलू उद्योगों के विकास के लिये भी, चुने हुए देहाती क्षेत्रों में, प्रयोगात्मक योजनायें चलाई जा रही हैं। इनका अन्तिम व्यय देहाती लोगों की अर्थव्यवस्था को सन्तुलित और विविध बनाना है।

६. मेरी सरकार ने जनशक्ति के उपयोग के लिये दिल्ली में 'बधाई हैन यादव रिसर्च' नामक संस्था स्थापित करने की दिशा में कदम उठाये हैं। तीसरी पंचवर्षीय योजना की रूपरेखा के अनुसार बेरोजगारी दूर करने और बेरोजगारों की सहायता करने के लिए एक योजना तैयार की गई है। मजदूर अनुसन्धान के लिये बम्बई में एक केन्द्रीय संस्था स्थापित जा रही है। आशा है तीसरी योजना में दिये व्ये अकादम शिक्षण-सम्बन्धी कार्यक्रम से इस श्रेणी के अधिकांश लोग लाभ उठा सकें। इस योजना का व्यय हमारे राष्ट्रीय लक्ष्यों तथा आज्ञायक स्थिरान्तरों के समझने को प्रेरित करता है जिसके लिए हमारे देश भी भजदूरों से जान तथा हुनर का प्रसार करना है जिसके लिए वे लोग अधिक अच्छी तरह अपना संगठन कर सकें।

७. कृषि-उत्पादन देशी से बढ़ रहा है और खाद्य की स्थिति आम तौर से अस्तित्व सन्तोषजनक है। कुछ क्षेत्रों में बिजली की कमी के अकाली औरोगिक उत्पादन में व्यापार वर बृद्धि हो रही है।

८. अनुशक्ति के क्षेत्र में, ज्ञाती जीव विज्ञान,

उद्योग और विकित्सा में काम आने वाले रेडियो आइसोटोप का उत्पादन भी आगे बढ़ा है। द्राघे में तैयार किये गये रेडियो-कोबाल्ट भव देश भर के अस्पतालों में उपलब्ध हैं। अणुशक्ति के शान्तिपूर्ण उपयोग में सहयोग तथा विकास के लिये गत वर्ष हंगरी, स्वीडन और सोवियत संघ के साथ हमारी संविधां हुई हैं।

६. पंचायती राज में हमारे लोगों को अपनी ओर बहुत ग्राहकर्त्तव्यत किया है, क्योंकि वह हमारी परम्परा और विचारधारा के अनुरूप है। पंचायती राज चार और राज्यों में लागू होने जा रहा है। इस प्रकार कुल मिला कर वह बारह राज्यों में लागू हो जायेगा।

१०. बरौनी में सार्वजनिक खण्ड में आने वाले दूसरे तेलशोधक कारखाने पर काम जारी है। इसकारखाने में प्रतिवर्ष २० लाख टन तेल साफ किया जायेगा। दस लाख टन की क्षमता वाला पहला कारखाना आगामी १२ महीनों में काम करने लगेगा।

११. नूनमाटी से सिलीगुड़ी तक और कलकत्ते से बरौनी होकर दिल्ली तक तेल की दुलाई के लिये पाइप लाइनें बिछाने की योजना है। देश के पश्चिमी भाग में तेल क्षेत्रों को प्रस्तावित तेलशोधक कारखाने के साथ और इस कारखाने को अहमदाबाद के साथ पाइप लाइन से जोड़ा जायेगा पूर्व में पेट्रोलियम के उत्पादन से परिवहन और पश्चिम में कच्चे तेल, गैस और तैयार माल की दुलाई के लिये तेल क्षेत्रों से बिभिन्न शक्ति-संस्थाओं तक पाइप लाइनें ले जायी जायेंगी। पाइप लाइनें बिछाने का यह कार्य तीसरी पंचवर्षीय योजना की अवधि में पूर्ण हो जायेगा। इससे हमारी रेल व्यवस्था पर सामान की दुलाई का बोझ काफी हल्का हो जायेगा।

१२. भारत को अठारह-राष्ट्र निःशस्त्री-करण समिति और संयुक्त राष्ट्र की प्रस्ताव कार्यान्वय संविधि का सदस्य चुना गया है।

जिनेवा में होने वाली निःशस्त्रीकरण सम्बन्धी बातचीत में अभी तक विशेष प्रगति नहीं हो पायी है। निःशस्त्रीकरण के व्येय की प्राप्ति के अभाव में सम्मेलन की कोशिशें ऐसी समस्याओं को सुलझाने के लिये जारी हैं, जैसे अणुबम के प्रयोगात्मक विस्फोटों की रोकथाम, अचानक आक्रमणों पर प्रतिबन्ध लगा कर राष्ट्रों के बीच विश्वास की भावना पैदा करना, अणुप्रभाव से मुक्त क्षेत्रों के सम्बन्ध में समझौता और शस्त्रीकरण की दौड़ की रोकथाम करना। निःशस्त्रीकरण संघ का सर्वामान्य प्रारूप तैयार करने में भी सम्मेलन व्यस्त है। इस संघ की प्रस्तावना इस समय बिचाराधीन है। इस सम्मेलन के प्रयत्न सफल हों और बातचीत संवेद आगे बढ़ाती रहे, इसके लिये मेरी सरकार मर्वोत्तम और सम्पूर्ण प्रयत्न करेगी। हमारा प्रतिनिधि मंडल, अन्य राष्ट्रों के साथ, अणुविस्फोटों की रोकथाम के लिये प्रस्तावों को प्रस्तुत करने और उनका समर्थन करने में विशेष रूप से और इस कार्य को अत्यन्त अवश्यक मानकर पूरी सहायता देता।

१३. १६६२-६३ के लिये अन्तर्रिम बजट विगत संसद् के सामने रखा गया था और वर्ष के एक भाग के लिये आय-व्यय पर यतदान द्वारा खर्च करने की अनुमति ले ली गई थी। नई संसद् के सामने भी इसी सत्र में आवश्यक संशोधनों के साथ बजट पेश किया जायेगा और समस्त वर्ष के लिये संसद् से धनराशि स्वीकृत करने की प्रारंभना की जायेगी।

१४. मेरी सरकार निम्नलिखित विधेयक पेश करना चाहती है :

१५. संसद के सदस्यगण, गणराज्य के: राष्ट्रपति के रूप में आपके सम्मुख अभिभावण देने का मेरे लिये यह अन्तिम अवसर है। बाहर वर्षों से अधिक समय तक लोगों द्वारा निर्वाचित अध्यक्ष के रूप में देश की सेवा करने का सुयोग मुझे मिला, यह मेरे लिये बड़ी लुभी और सौभाग्य की बात है। इस उच्च पद को स्वीकार करने से पहले, संसदीय जीवन और उसके कर्तव्यों का भी मुझे कुछ

मनुभव रहा है। उसके लिये मेरे मन में अधिक से अधिक आदर है और संसदीय प्रणाली तथा उसकी संस्थाओं में मेरा आकाशपूर्ण विश्वास और गहरी आस्था है। इस में मुझे संदेह नहीं कि आप अपने पूर्वाधिकारियों द्वारा स्थापित उच्च परम्पराओं को बनाये रखेंगे।

१६. यह भी सौभाग्य की बात है कि हमारी संसद के प्रति लोगों की आदर भावना है और हमारी राजनीतिक भावनाओं में इसकी जड़ें गहरी जम गई हैं। यद्यपि इसके मूल आदर्श और कार्यप्रणाली ब्रिटिश पालियार्मेंट से लिये गये हैं, हमारी संसद ने अपना सजीव व्यक्तित्व विकसित किया है और यह प्रक्रिया बराबर जारी है। हमने अपने अनुभव के आधार पर और अपनी आवश्यकताओं के अनुसार अपनी रीतियों प्रौद्योगिकीय विधियों की स्थापना की है।

१७. जैसा कि मैंने अपने पिछले अभिभावण में कहा था, मेरी सरकार का उद्देश्य और लक्ष्य अपनी नीतियों पर दृढ़ानपूर्वक चलना और अपने देश में लोकतंत्रात्मक तथा समाजवादी समाज की स्थापना के लिये प्रभावपूर्ण कार्यवाही करना है। ऐसा करने से ही राष्ट्रीय उन्नति तथा उत्पादन में वृद्धि सामाजिक न्याय का रूप ले सकती है, उन्नति की वेगवती प्रवृत्ति शांतिपूर्ण रह सकती है और हमारा देश दृढ़ता और तेजी से आगे बढ़ सकता है।

१८. अब मैं आप से विदा करता हूँ और आपको आपका कार्यभार सौंपता हूँ। मुझे विश्वास है कि आपके अनुभव, देशभक्तिपूर्ण उत्साह और अपने कर्तव्य के प्रति समर्पण की भावना, आपकी त्यागपूर्ण कर्तव्य-प्रतापता तथा दक्षता और जो जहरी काम हमारी राह देख रहे हैं उनकी पुकार, हमेशा और पूरी तरह इस कार्य को प्राप्त करेंगी।

१६. मैं भाषण का शुभ आहता हूँ। आप सब और हमारी लोकतंत्रात्मक संस्थाएं स्थायी और शक्तिशाली बनें, लोगों को जनतंत्रात्मक प्रवर्सों के लिये अधिकाधिक प्रेरित करें और शांति, तथा अन्तर्राष्ट्रीय सहयोग को उन्नत करने में सहायक हों, यही मेरी कामना है।

#### Members of Parliament:

It gives me great pleasure to welcome you, Members of the Third Parliament of our Republic, to its inaugural session. Amongst you are a large number who have been Members of Parliament in years past and who once again sought the suffrage of your respective electorates and received at their hands a renewal of confidence. There are others among you who, though not new to public life or perhaps even to legislatures, have been elected to Parliament for the first time.

2. I congratulate you all and welcome you to united endeavour in the service of our common motherland. Each one of you will find in your tenure as Members of Parliament, whether it be in the legislature itself or in your constituencies, vast and varied opportunities and compelling necessities, for sustained and constructive work in the service of our country. The task of nationbuilding for which Parliament has both the continuing and ultimate responsibility, calls for the full exercise of your capacities of deliberation, analysis, constructive criticism, vigilance and dedication.

3. About a month ago I addressed the last session of the Second Parliament and bade them farewell. I then surveyed briefly the progress that was being achieved in different fields of our national life and effort. The country has made progress in many fields even during the short period between that occasion and now when I have the privilege to welcome you.

4. Our planned economy is the basis of our material development and of the maintenance of a dynamic, social

and economic equilibrium. The Third Five Year Plan is in its second year and has made a good start. It is envisaged as a large-scale effort to build up our national economy, to increase productivity and employment and to ensure the development of society on the basis of justice, social, economic and political, as enjoined by our Constitution. The Plan must increasingly bring within its scope of implementation larger numbers of our people as participants in production with both skills and understanding of the national objective.

5. Pilot projects for the utilisation of rural manpower were initiated some time ago. This rural works programme is being expanded and now covers 200 development blocks. Pilot projects for the intensive development of village and small industries in selected rural areas are also being taken up, the ultimate aim being to bring about a diversified and balanced economy in all rural areas.

6. My Government have also taken steps for setting up an Institute of Applied Manpower Research in Delhi. A scheme for the establishment of unemployment relief and assistance as set out in the Third Five Year Plan has been drawn up. A Central Institute of Labour Research is to be set up at Bombay. A substantial portion of the working force is also expected to be covered during the Third Plan period under the scheme of workers' education. This is meant to promote the appreciation of our national objectives, as well as the understanding of the basic principle and the acquisition of the knowledge and skills which would help workers to organise themselves.

7. Agricultural production is steadily moving up and the food situation in general is quite satisfactory. Industrial production maintains an upward trend despite power shortages in some areas.

8. In the field of Atomic Energy, the production of Radio Isotopes for use in agriculture, biology, industry and medicine has registered an increase.

Radio cobalt produced at Trombay is now made available to hospitals in the country. Agreements of collaboration and development in the use of atomic energy for peaceful purposes were concluded last year with Hungary, Sweden and the Union of Soviet Socialist Republics.

9. Panchayati Raj which has caught the imagination of our people, it being so well in accord with our traditions and our way of thinking, is to be implemented in four more States, bringing the total number to twelve.

10. The work on a second refinery in the public sector at Barauni is in progress. It will process two million tons of crude oil per annum. The first one million ton unit is scheduled to be commissioned within the next twelve months.

11. It is proposed to have a chain of pipelines from Nunmati to Siliguri and from Calcutta to Delhi via Barauni. In the western part of the country pipelines will link the oil fields with the proposed refinery, and a product pipeline will run from the refinery to Ahmedabad; also small gas lines from the oil fields to different power stations for transporting petroleum products in the east and crude oil, gas and finished products in the west. These pipelines are scheduled to be completed within the Third Five Year Plan period. They will afford considerable relief to our railway transport system.

12. India has been elected a member of the Disarmament Committee of 18 Nations and also of the Committee for the implementation of the Resolutions of the United Nations. No appreciable progress has yet been effected in the deliberations on disarmament at Geneva. The Conference is continuing its efforts, pending achievement of general and complete disarmament, to deal with specific issues such as cessation of nuclear test explosions, avoidance of surprise attacks thereby increasing confidence among nations, agreement on nuclear-free

zones, a halt in the armament race. The Conference is also engaged on reaching agreement on the draft of a Disarmament Treaty. Its preamble is now under consideration. My Government will use their best and dedicated endeavour for speedy progress and the successful outcome of the Conference. In particular and as a matter of most immediate concern, along with other Nations our Delegation will help to initiate and support proposals for the cessation of nuclear tests.

13. An interim Budget for 1962-63 was presented in the last Parliament and votes on account authorising expenditure for a part of the year obtained. A Budget will be presented again to the new Parliament in this session, with such changes, as may be considered necessary, and Parliament asked to approve funds for the whole year.

14. My Government propose to introduce the following Bills:

- (10) The Minimum Wages (Amendment) Bill.
- (11) The Factories (Amendment) Bill.
- (12) The Payment of Wages (Amendment) Bill.
- (13) The Workmen's Compensation (Amendment) Bill.
- (14) The Industrial Disputes (Amendment) Bill.

- (15) The Working Journalists (Amendment) Bill.
- (16) The Employees' Provident Fund (Amendment) Bill.
- (17) The Employees' State Insurance (Amendment) Bill.
- (18) The Wealth Tax (Amendment) Bill.
- (19) The Finance Bill (No. 2).

15. Members of Parliament: This is the last occasion on which I shall address you as the President of the Republic. It has been a great joy and privilege for me to serve our motherland as the elected head of the people for over twelve years. I have had my share of Parliamentary life and duties prior to acceptance of this high office and cherish the highest regard for and confident hopes in our Parliamentary institutions and ways. I have no doubt that you will maintain the high traditions established by your predecessors.

16. It is also our good fortune that our Parliament enjoys the respect of our people and it has become rooted in our political sentiments. While it derived its basic norms and procedures from the British Parliament, it has developed its own dynamism and it continues to do so, establishing its own conventions and methods born in the context of our own experience and needs.

17. As I said in my last address it is the objective and purpose of my Government to follow steadfastly firm policies and to implement effective measures to establish in our land a democratic and socialist society. Thus alone will national progress and increase in productivity be synonymous with social justice, and dynamic progress will be peaceful and our country will march with firmness and speed.

18. I now bid you farewell and leave you to your labours, confident that with your experience, your patriotic fervour and your sense of dedication to duty, the imperative

call of the urgent tasks that await us will always and in full measure command your skill and dedication.

19. I wish you well. May all of you and our Parliamentary institutions progress in strength and stability, inspire our people to more and more democratic endeavour and assist in the process of the growth of peace and international co-operation.
