3. The Report was considered and adopted by the Committee at their sitting held on 15.12.2022.

## CHAPTER I

### PART I

#### Report

#### Introductory

1.1 GAIL (India) Ltd. was incorporated in August, 1984 as a Central Public Sector Undertaking (PSU) under the Ministry of Petroleum and Natural Gas (MoP&NG), with the mission of “accelerating and optimizing the effective and economic use of Natural Gas and its fractions for the benefit of the national economy”. Government of India now holds 51.45% shares of the company. GAIL became a Navratna in 1997 and is now one of the Maharatna Public Sector Undertakings, the highest status conferred to any PSU.

1.2 GAIL started as a Gas Transmission Company during the late eighties and has grown organically by setting up a large network of Natural Gas pipelines of ~. 13,700 Km; two LPG Pipeline systems of ~ 2000 Km; five Gas Processing plants for production of LPG and other liquid hydrocarbons with a combined production capacity of around 1.4 MMTPA and a gas based integrated petrochemical plant of capacity 810 KTPA of polymer. GAIL is co-promoter of two other petrochemical projects including 280 KTPA Brahmaputra Cracker and Polymer Limited (BCPL) Complex in Assam and 1.4 MMTPA ONGC Petro-additions Limited (OPaL) project in Gujarat. Petronet LNG, a JV of GAIL, operates two LNG regasification terminals at Dahej and Kochi. GAIL is also the promoter of Konkan LNG Private Limited which operates LNG regasification terminal at Dhabol with design capacity of 5 MMTPA.

1.3 GAIL is a pioneer in city gas distribution (CGD) business in India. It has presence in 61 Geographical Areas across India with 8 JVs and three wholly owned subsidiaries. GAIL has implemented CGD projects in major Indian cities including New Delhi, Mumbai, Kolkata, Bangalore, Hyderabad, Pune, Lucknow, Indore, Bhopal etc. to supply gas to domestic and transport sector. These CGD networks together cater to around 65% of over 85 lakh domestic PNG connections in the country. Further, GAIL operates 55% of India’s CNG stations through JVs and subsidiary.

**International Presence:**

1.4 It has also been informed that GAIL has overseas presence in USA, Singapore, Myanmar, China and Egypt. It has opened offices in Singapore, Yangon, Houston and Moscow (Bharat Energy Office). It has a wholly owned subsidiary, GAIL Global (USA) Inc. (GGUI) in USA. GGUI has formed subsidiary, GAIL Global (USA) LNG LLC (GGULL) which has booked 2.3 MMTPA capacity in Dominion Cove Point LNG liquefaction project. GAIL has another wholly-owned subsidiary company viz. GAIL Global (Singapore) Pte. Ltd., for trading in LNG and for undertaking overseas investments.

1.5 GAIL has integrated into upstream business of Exploration and Production with participating interests in 9 blocks in India and 2 in Myanmar. Besides, GAIL has 4.17% equity partnership in South East Asia Gas Pipeline Company (SEAGP) which is transporting gas from Myanmar to China.

1.6 GAIL has executed a long-term LNG Sale and Purchase Agreement with Sabine Pass Liquefaction LLC for purchase of 3.5 Million Tons per Annum (MMTPA) and Gazprom Marketing and Trading Singapore for supply of 2.5 MMTPA of LNG.

**GAIL in Renewable Energy Sector:**

1.7 GAIL has renewable portfolio of ~130 MW including ~118MW of wind and ~12 MW of solar energy. GAIL has installed India's 2nd largest solar roof top of 5.76 MW grid connected captive solar power plant at Pata Petrochemical complex. In addition, GAIL is exploring various business opportunities in the Production and Marketing of Compressed Bio Gas (CBG) from organic waste. Emerging areas including ethanol, hydrogen, etc. are also being explored for new business opportunities. GAIL has started hydrogen blending as a pilot project to establish the techno-commercial feasibility of blending hydrogen in the CGD network. Further, GAIL is setting up a 10 MW green hydrogen plant which will be one of the largest green hydrogen plants in the world.

1.8 In connection with the examination of the subject "Measures undertaken to secure representation of OBCs in employment and for their welfare in Gas Authority of

India Limited (GAIL)”, the Committee obtained Background Note/Written Replies from the Ministry of Petroleum and Natural Gas, apart from taking the oral evidence of the representatives of the Ministry of Petroleum and Natural Gas and GAIL. The Committee also undertook study visit to Srinagar, Chandigarh and Shimla to obtain feedback at the field level. Based on the written submissions and oral deposition of the representatives of the Ministry of Petroleum and Natural Gas and GAIL and inputs gathered during on-the-spot Study Visit, the Committee have examined the subject in detail as enumerated in the succeeding paragraphs.

### **Organizational Set-up**

1.9 The composition of the Board of Directors of GAIL is given below:-

**PART-TIME NON OFFICIAL DIRECTOR (INDEPENDENT): 08 (02 Vacant)**

1.10 The organisation chart of Board of Directors of GAIL is given at *Annexure-I*.

1.11 As on date, the Board also consists of 01 part time Director from the Ministry of Petroleum and Natural Gas, Government of India and 06 Independent Directors. GAIL also has on deputation from the Government a senior level officer as Chief Vigilance Officer.

1.12 On being asked about the number of officials belonging to OBC category occupying the position in the Board/Top Management Body of GAIL, the representatives of the Ministry deposed that –

“At present, there is no Director belonging to OBC category in the Board of Directors of GAIL”.

1.13 The Committee also enquired about reasons for no representation of OBC at Director level in the organisation. The Ministry replied that -

“The selection/appointment of Board level positions in PSEs is decided by Public Enterprise Selection Board (PESB), DPE, Govt. of India”.

## CHAPTER II

### REPRESENTATION OF OBCs IN GAIL

#### Staff Strength

2.1 Asked about the total staff strength and number of OBC employees at various levels of posts in the hierarchy in GAIL, the Ministry of Petroleum and Natural Gas informed as under –

“The total staff strength at various levels of posts in GAIL India Limited and the number of OBC employees therein as on 30.04.2022:-

2.2. It would be seen from the above data, the representation of OBC employees in Group 'A' in GAIL is 21.02% which is quite low and as such there is shortfall of OBC vacancies. The overall representation of OBCs in GAIL is only **23.86** percent which is much below prescribed 27 percent. Asked about the reasons for the same, the Ministry stated as under –

- (a) The non-availability of suitable OBC candidates for filling up reserved OBC posts in highly specialized disciplines like Fire & Safety, E&P, Boiler Operations, Instrumentation etc. in Group-A (Management) post and experienced Plant Operators, Boiler Operators, Technicians and Foreman in Group-C (Non-Management) post.
- (b) Some of the selected OBC category candidates in general and especially in technical disciplines do not finally join the offered post even after accepting the offers.
- (c) Some of the OBC category candidates are also being selected on merit against UR vacancies and in case sufficient numbers of candidates are not available, then also some of these posts remain vacant. For instance, in the year 2021, in Group A, 08 candidates belonging to OBC (NCL) category were selected on merit against UR vacancies through Campus Recruitment Drive – 2020-21.

Notwithstanding the above, all efforts are being made to clear the backlog vacancies by initiating Special Recruitment Drive (SRD) and re-advertising the unfilled vacancies, from time to time”.

Furthermore, the Ministry informed that -

“GAIL has been providing reservation to OBCs in Direct Recruitment in Group-‘A’ (Management) post and Group ‘B’, ‘C’ & ‘D’ (Non-Management) posts as per Presidential Directives and other guidelines received from Government of India from time to time. There are 02 mode of recruitment in Group A-

1. Direct Recruitment on All India basis by open competition-27% reservation for OBCs; and
2. Direct Recruitment on All India basis otherwise than by open competition – 25.84% reservation for OBCs.”.

2.3 The Committee desired to know about categories of posts in the organization (Technical and Non-technical) wherein reservation is made for OBCs along with pay scales of all such posts. In reply, the Ministry submitted as under:-

“GAIL provides reservations for OBC as per the Government’s directives in all posts for which direct recruitment is conducted. Categories of posts (both Technical and Non-technical) for which reservations are being made in direct recruitment for OBC candidates with effect from 08.09.1993 are indicated below along with their applicable pay scales”.

2.4 When asked to provide details of the present strength of employees both in Management and Non-management categories which are filled through direct recruitment and also the total number of OBCs along with their percentage, the Ministry submitted as under:

“Representation of OBC category employees in GAIL as on 30.04.2022 is given at Table below:

2.5 It may be seen from the above data that there has been low representation of OBCs not only in Group ‘A’ but also in overall staff strength in GAIL and desired to know the reasons thereof. The representative of the Ministry deposed in evidence-

“Sir, so far as human resources in GAIL is concerned, today the staff strength is 4779. Since its inception in 1984, the OBCs staff in GAIL is 23.86% as on date. With the implementation of reservation policy for OBCs in 1993, the OBC strength in GAIL is 26.55%. I would like to draw your attention towards a fact that 27% seats are reserved for OBCs. But in GAIL we recruit experienced cadre. As per the guidelines for experienced cadre, only 25.8% seats are reserved for them. This means we have more OBCs staff in GAIL. Today 26.55% staff belongs to OBCs category. It has always been our endeavor that we can make this percentage much better. If an OBC candidate comes on merit in the selection process, we recruit them in UR category. That percentage has not been added to it. We have shown here only the percentage of OBC staff recruited against reservation.”



### CHAPTER III

#### **IMPLEMENTATION OF RESERVATION POLICY FOR OBCs IN RECRUITMENT**

3.1 Elaborating on the implementation of the reservation policy for OBCs in various categories of posts in the organization, the Ministry submitted as under-

“GAIL has been providing reservation to OBCs in Direct Recruitment as per directives of Government of India with effect from 08.09.1993. Reservation to OBCs is being provided in Direct Recruitment in Group-‘A’ (Management) post and Group ‘B’, ‘C’ and ‘D’ (Non-Management) posts as per Presidential Directives and other guidelines received from Government of India from time to time.

The reservation applicable to OBCs in posts filled through Direct Recruitment on All India basis by open competition in Group-‘A’ (Management) post and Group ‘B’ (Non-Management) post is 27% and in the posts filled through Direct Recruitment on All India basis otherwise than by open competition in Group-‘A’ (Management) post and Group ‘B’ (Non-management) post, it is 25.84%.

Furthermore, reservation to OBCs for the posts filled by direct recruitment in Group-‘C’ and ‘D’ (Non-Management) on All India basis by open competition is 27%.”

3.2 The Committee desired to know about concessions and relaxations which are given to OBCs in direct recruitment, the Ministry stated as under-

“Following concessions and relaxations are given to OBCs in direct recruitment-

- Relaxation in upper age limit: The upper age limit is relaxable by 03 years for OBC (NCL) category candidates and 13 years for OBC (NCL)-PwBD category candidates.
- OBC (NCL) category candidates are interviewed/ selected with relaxed standard.
- OBC (NCL) category candidates are interviewed on separate day/ in separate session.
- To and fro journey fare to outstation OBC (NCL) category candidates for appearing in the Interview.
- OBC (NCL) category candidates, selected on merit are considered against unreserved (UR) vacancies and they are not adjusted against their respective quota”.

## CHAPTER IV

### **BACKLOG VACANCIES AND SPECIAL RECRUITMENT DRIVE**

4.1 On being asked to furnish the details of backlog/ shortfall of OBC vacancies in GAIL and steps taken to fill up these vacant positions, the Ministry stated as follows:

“Continuous efforts are being made in GAIL through Special Recruitment Drive (SRD) as well as inclusion of shortfall/backlog vacancies in normal recruitments to fill up the backlog/shortfall vacancies. In order to fill up the backlog vacancies, Special Recruitment Drives (SRD) was also launched in the year 2018 for filling up **07** backlog vacancies of OBCs in **Group-A**, **11** backlog vacancies of OBCs in **Group-B** and **16** backlog vacancies of OBCs in **Group-C**.

During 2018-19, two such recruitment exercises have been carried out in order to fill up the backlog vacancies for OBC Category candidates. The detail of the same is mentioned below:-

In order to fill up the backlog vacancies, Special Recruitment Drives (SRD) was launched in the year 2018 for filling up 07 backlog vacancies of OBCs in Group-A, 11 backlog vacancies of OBCs in Group-B and 16 backlog vacancies of OBCs in Group-C.

Out of 07 backlog vacancies of OBCs in Group-A, 04 vacancies reserved for OBC have been filled.

Out of 11 backlog vacancies of OBCs in Group-B, 08 vacancies reserved for OBC have been filled.

Out of 16 backlog vacancies of OBCs in Group-C, 12 vacancies reserved for OBC have been filled.

Summary of backlog vacancies cleared/filled in 2019:-

All efforts are being made to wipe out the shortfall/backlog vacancies by initiating Special Recruitment Drive (SRD) and re-advertising the unfilled vacancies”.

4.2 The Committee desired to know the present status of backlog vacancies reserved for OBCs in Direct Recruitment in GAIL, the Ministry submitted *inter-alia* -

“Backlog of vacancies reserved for OBCs in Direct Recruitment in GAIL as on 31.12.2021 is given at Table below:-

14 candidates have been selected against 24 backlog vacancies in Management cadre through various advertisements. Balance 10 backlog vacancies in Management cadre and 29 backlog vacancies in Non- Management cadre will be notified in the proposed recruitment plan for 2022-23 including Special Recruitment Drive and this recruitment exercise is expected to be completed in this FY 2022-23.”

## CHAPTER V

### **MONITORING MECHANISM FOR IMPLEMENTATION OF RESERVATION POLICY**

5.1 When asked by the Committee about the steps taken by the Ministry to ensure proper implementation of the reservation policy for Other Backward Classes, the Ministry in a written reply stated -

“Since Beginning, abiding with the government guidelines, GAIL has been maintaining Reservation Rosters as per the Presidential Directives.

A separate **Chief Liaison Officer (CLO)** has been nominated in GAIL, for looking after matters relating to the reservation for and employment of Other Backward Classes (OBCs).

The implementation of reservation policy is monitored and ensured in terms of the provisions contained in Presidential Directives and instructions received from time to time from the Government through the Department of Public Enterprises (DPE) and Ministry of Petroleum and Natural Gas. Liaison Officer in Administrative Ministry *i.e.* Ministry of Petroleum and Natural Gas carries out inspection of rosters.

Following measures are taken to ensure reservations for OBCs:-

- (i) Periodic/Regular maintenance of Reservation Rosters;
- (ii) Periodic inspection of Reservation Rosters by Chief Liaison Officer for OBCs;
- (iii) Periodic inspection of Reservation Rosters by the Liaison Officer of Ministry of Petroleum and Natural Gas;
- (iv) Timely submission of reports to the Appropriate Authorities regarding the appointments of OBC candidates;
- (v) Nominating one OBC member in the Selection Committees to ensure compliance of Presidential Directives on Reservations for, and employment of OBCs;
- (vi) Training is imparted to Chief Liaison Officer and the dealing officers for ensuring proper implementation of Reservation policies as received from Government of India from time to time.”

### **Liaison Officer for OBCs**

5.2 The Committee enquired about the appointment of Liaison Officers in GAIL, the Ministry informed that a separate Chief Liaison Officer (CLO) has been nominated in GAIL at Corporate level for enforcement of the reservation policy and other welfare measures. It was further informed that the Chief General Manager (HR) has been performing the role of Chief Liaison Officer (CLO) for OBCs in GAIL and he belongs to OBC category only.

### **Grievance Redressal Machinery**

5.3 As regards the procedure prescribed for redressal of grievances of Other Backward Classes employees, the Ministry stated as under:-

“An Online Grievance Redressal System exists in the Company so as to ensure prompt monitoring and speedy disposal of grievances of all employee (including OBC employees). This three tier Online Grievance Redressal System is a user-friendly workflow application available on GAIL Intranet Homepage.

#### **Broad outlines of the Online Grievance Redressal System are placed as below:-**

**Step I:** By making use of Online Grievance Redressal Mechanism, an aggrieved employee can register his/ her grievance to the concerned HR In-charge who is expected to settle the same within a period of 10 days from the date of registration of the grievance. On expiry of the stipulated time period, the instant grievance will automatically get transferred to Corporate HR Deptt. for disposal at its end.

**Step II:** In case, an aggrieved employee is not satisfied with response given by his concerned HR In-charge, he/ she may take up the matter with Corporate HR Deptt. For such appeals, Chief General Manager (HR), Corporate Office is the designated officer who will respond to the employee concerned within a period of 15 days from the date of receipt of the grievance.

**Step III:** In case an aggrieved employee is not satisfied with the response given by Corporate HR Deptt., he/ she may prefer an appeal to Director (HR) by using the Online Grievance Redressal System. Director (HR) may take feedback from

concerned executive(s) and respond to the employee concerned within a period of 15 days from the date of receipt of appeal. Such settlement of grievance by Director (HR) will be final and binding on all the concerned.”

5.4 The Committee desired to know about the number of complaints received from OBCs employees during each of the last two years. In reply, the Ministry submitted as follows:

“No complaint has been raised by OBC employees during the last two years.”

5.5 When the Committee enquired about holding periodic meetings with Other Backward Classes employees to sort out their problems and grievances, the Ministry in a note stated as follows:-

“There is no OBC employees’ welfare association/union in GAIL (India) Limited as of now. However, there is an employee collective body for representation of issues of executives (GOA) and an employee collective body for representation of issues of non-executives (GEA) in which there is representation of OBC employees. Periodic meetings with both GOA and GEA take place from time to time.”

### **Transfer Policy**

5.6 The Committee sought information regarding transfer policy being followed in GAIL. In response, the Ministry stated as under-

“Transfer/Placement of employees are normally effected in April/May every year through Annual Placement exercise (APE) keeping in view various contextual factors including on-going/emerging business requirements, provisions mentioned in Transfer guidelines, as also individual difficulties of employees.

In the last concluded APE-2021 exercise, total 32 Nos. of representation were received from OBC employees. All the representations received have been suitably replied.

All employees are given the opportunity to make submission with regard to any difficulty in respect of their transfer. Such representations from employees (irrespective of the category to which they belong to) are examined and

addressed suitably. However, there is no case in which any employee has expressed concern with regard to discrimination/ harassment/ exploitation based on his/ her belonging to OBC category”.

## CHAPTER VI

### **HUMAN RESOURCE TRAINING**

6.1 In response to a query about Human Resource Training, the Ministry stated as follows:-

“GAIL established its Training Centre "GAIL Training Institute" (GTI) at Noida in the year 1997 with the assistance from DANIDA (Danish International Development Agency). In 2005, GAIL established another Training Institute at Jaipur for workmen and other non – executives. Since beginning, GTI has been endeavouring to develop itself as a leading Training Institute by offering various training programmes related to the Gas Value Chain for professional development of executives and workmen working in the Oil and Gas sector and is an ISO 9001:2015 Certified Institute. To achieve the vision of GAIL, GTI is continually working to further sharpen knowledge, skills, aptitude and attitude of its employees by understanding the changes taking place in global business dynamics with the help of latest technology and resources.

In the wake of COVID-19 and the subsequent challenging time, GTI swiftly changed its pedagogy of Learning and Development by shifting it to virtual training mode, for which GTI Co-ordinators and GAIL Internal faculty members were promptly trained to cope up with the changed L&D requirements. After overcoming the challenging situations, GTI has resumed back to physical trainings mode in April 2022.

Since beginning, GTI has been endeavoring to develop itself as a leading training Institute by offering various training programs related to the gas value chain for professional development of executives and workmen working in the Oil and Gas sector.



The following are the details of the training imparted to GAIL Employees during last five years are as follows.

GTI has a dedicated faculty base with a long experience and expertise in the areas of Natural Gas and LPG Pipeline Construction and O&M, Compressor Stations, Petrochemicals, City Gas Distribution (CGD) and Compressed Natural Gas(CNG), SAP-ERP, Cathodic Protection, Integrity Management, Quality Management, Health, Safety and Environment, etc. In addition to its core faculty, GTI has developed various in-house experts for conducting focused programs. The faculty pool consists of specialists with excellent background in industry,

teaching and consulting. They are highly diversified group of individuals, who have graduated from leading Management and Technical institutions including IITs and BITS Pilani.”

**CHAPTER - VII****OUTSOURCING OF SERVICES/JOB**

7.1 The Committee asked whether GAIL is outsourcing some of their non-core functions. In reply, the Ministry stated as under-

"Yes, GAIL currently outsources manpower for its non-core functions in limited areas wherever required as service contract.

The unit wise detail of contract workers deployed in the service contracts is attached at ***Annexure-II.***"

7.2 During the oral evidence, on a specific query of the Committee regarding representation of OBCs in Outsourcing jobs, the representative of the Ministry apprised the Committee as under:

"GAIL incorporated contract provisions to secure the interest of OBCs in outsourced jobs.

The provision in the contract document is reproduced as under:

*"While engaging / deploying the resources, the Contractor is required to make efforts to provide opportunity of employment to resources belonging to **Schedule Caste, Schedule Tribe and Other Backward Class** in order to have a fair representation of these sections of the society."*

7.3 In reply to a query about the steps taken by the Ministry to secure the interest of OBCs in outsourced jobs, the Ministry stated that GAIL ensures that Contractors who engaged contract labourers adhere to all applicable Government guidelines.

**CHAPTER VIII****CORPORATE SOCIAL RESPONSIBILITY**

8.1 When asked about various initiatives taken and the amount spent under Corporate Social Responsibility, the Ministry in written reply stated as under-

“In FY 2021-22, the major CSR projects undertaken by GAIL, under the identified thrust areas of CSR umbrella ‘GAIL Hriday’ , are as below:

**a) GAIL Arogya (Wellness)- Nutrition, Health and Sanitation and Drinking Water projects:**

- (i) Primary health care services has been provided at door steps of underprivileged villagers having limited access to health services through operation of 60 nos. of Mobile Medical Units (MMUs) covering 37 districts in 12 nos. of States across India. Each MMU includes one Doctor (MBBS), Nurse, Lab Technician, Pharmacist, essential medicines, diagnostic kit (Swasthya Jaanch Machine), Sanitary napkins, water purification tablets, IEC material on health and hygiene and a GPS. Approx. 25,000 patients are benefitted through each van in a year.

**b) GAIL Ujjwal (Towards a Bright future) – Education initiatives**

GAIL Utkarsh: , All-expense paid specialized residential coaching is provided to meritorious children from marginalized communities for top engineering college entrance examinations at four of GAIL Utkarsh centres- Kanpur and Varanasi (Uttar Pradesh), Haldwani and Srinagar (Uttarakhand). In FY 2021-22, total 262 candidates have benefitted under the project, viz. 100 students provided coaching at Kanpur centre, 62 female students provided coaching at Varanasi centre, 50 students each provided coaching at Haldwani and Srinagar centres.

**c) GAIL Kaushal (Skill) - Livelihood Generation and Skill development initiatives:**

In FY 2021-22, skill development training has been provided through following major activities undertaken under GAIL Kaushal are as below:

- (i) Skill training has been provided to 300 nos. of youths at GAIL Institute of Skills, Guna (Madhya Pradesh) and 85 nos. of youths at GAIL Institute of Skills, Nagaram (Andhra Pradesh) in trades like CNC Operator, Industrial welder, Industrial electrician, Customer Care Executive, Unarmed Security Guard and Draughtsman Mechanical.
- (ii) Support has been provided towards skill training to 115 beneficiaries in Plastic Product Manufacturing at Jaipur, Lucknow, Dehradun and Imphal centres of CIPET, an autonomous institute under the Ministry of Chemicals and Fertilizers.
- (iii) Investment to the tune of over Rs. 17.75 cr made towards Skill Development Institutes in Kochi (Kerala), Raebareli (UP), Vishakhapatnam (AP), Bhubaneswar (Odisha), Ahmedabad (Gujarat) and Guwahati (Assam) – Collaborative projects of Oil Sector PSUs.
- (iv) Skill training has been provided to total 244 women beneficiaries in trades like Domestic Data Entry Operator, Self Employed Tailoring and Assistant Beauty Therapist in urban slums of Delhi.

**d) GAIL Saksham (Capable) - Care of the elderly and differently abled:**

- (i) Support has been provided to 762 nos. of Persons with disabilities by supplying aids and assistive devices through organizing camps with ALIMCO. 03 nos. of assessment and distribution camps have been organized at Kashipur (Uttarakhand), Auraiya (Uttar Pradesh) and Kota and Bundi (Rajasthan) for distribution of the aids and assistive devices.

**e) GAIL Unnati (Progress)- Rural Development:**

Support has been provided towards various activities for development in rural areas such as construction of sheds, provision of clean drinking water, renovation and redevelopment work, renovation of cremation ground, installation of solar street lights in rural and remote areas in States like Uttar Pradesh, Madhya Pradesh, Uttarakhand, Andhra Pradesh, Kerala and Haryana

The details of CSR work undertaken by GAIL during the last three years is placed at ***Annexure-III***.

The amount spent by GAIL towards CSR activities during the last three years is as below:

8.2 As regards welfare of backward classes under CSR during the last three years, the Ministry in written reply have stated as under:

“GAIL implements its CSR programmes in alignment with the activities/schemes defined in schedule VII of the Companies Act 2013. The CSR activities of GAIL are implemented in and around rural communities and in close proximity to the business/operation locations of GAIL. Since majority of the GAIL CSR projects are undertaken in the remote/backward/tribal area districts, therefore majority of the beneficiaries are from the backward, marginalized and most disadvantaged segments of the society.

Although the CSR initiatives are not designed to target a particular caste/religion, the components of welfare and empowerment of backward and marginalized class and community is intrinsic to all CSR activities of GAIL and inherent in the culture of the organization. The major CSR initiatives of FY 2021-22 that have directly benefitted OBC community are as below:

- (i) GAIL Utkarsh: All-expense paid specialized residential coaching provided to 262 nos. of meritorious children through GAIL Utkarsh centres- Kanpur (100 students), Varanasi (62 students) (UP), Srinagar (50 students) and Haldwani (50 students) (Uttarakhand) in FY 2021-22. At Kanpur, Srinagar and Haldwani centres, coaching is provided for engineering entrance

examination and in Varanasi centre, an all girl coaching centre, coaching is provided for engineering as well as medical entrance exam.

Out of the total 262 students, 104 students (40%) are from OBC community.

- (ii) GAIL Vidya- Support provided towards promoting education to 350 underprivileged girl students from rural and semi-urban localities of NOIDA.

Out of the total 350 students, 106 students (30%) are from OBC community.

- (iii) Support provided for coaching for JEE/NEET entrance examination to 10 underprivileged students in Delhi/NCR. Out of these 10 students, 04 (40%) are from OBC community.

- (iv) Support has been extended for skill development training to 115 candidates in “Plastics Product Manufacturing Operator” at CIPET centres- Jaipur, Lucknow, Dehradun and Imphal. Out of total trained beneficiaries, 103 have already been employed. Placement process for rest of the candidates is undergoing.

Out of the total 115 trained candidates, 46 candidates (40%) are from OBC community.

- (v) Skill training provided to total 385 beneficiaries in hydrocarbon sectors at GAIL Institute of Skills at Nagaram (Rajahmundry, AP) and Guna (MP).

Out of the total 385 beneficiaries, 215 (56%) are from OBC community.

- (vi) Support provided for empowering 30 adolescent girls and women in skill trade on domestic data entry operator.

Out of the total 30 beneficiaries, 18 (60%) are from OBC community.

- (vii) Skill training provided to 170 women beneficiaries in skill trades on cutting and tailoring, beauty culture and compute operation in Pathankot, Punjab.

Out of the total 170 beneficiaries, 30 (18%) are from OBC community.

- (viii) Support provided for Skill Development programme in Ayurveda Panchakarma Therapy to 20 nos. of youths from families affected by COVID-19.

Out of the total 20 beneficiaries, 16 (80%) are from OBC community.

- (ix) Support has been provided to 543 nos. of Persons with disabilities, by conducting assessment and distribution camp for distributing Aids and Assistive devices to Divyangjans at Auraiya (UP), Kota and Bundi (Rajasthan).

Out of the total 543 beneficiaries, 362 (approx. 67%) are from OBC community.

- (x) Support extended for fitment of artificial limbs, Callipers, aids and appliances to 475 PwDs in Jaipur. Out of total 475 PwDs, 124 (26%) are from OBC community

- (xi) Support provided for construction of new building, land and maintenance at Nalgonda School for the Blind in Nalgonda, Telangana. Total 73 students studies at Nalgonda School for the blind and will be directly benefitted.

Out of the total 73 beneficiaries, 42 (58%) are from OBC community.

- (xii) Support provided for empowering 300 girl students through sports in 03 gender critical districts of Haryana: Gurugram, Mahendragarh and Kurukshetra. Out of total 300 students, 111 are from OBC (37%) community.

- (xiii) Support provided for training of 17 athletes selected under GAIL Indian Speed Star Season I, II, III. Out of total 17 students, 03 (18%) are from OBC community.

Thus, as per the above detail of major project of value of approx. 15.00 crores, 44% beneficiaries are from OBC community. For the rest of the projects where, as explained, the exact calculation for number of beneficiaries basis caste is not possible due to nature of projects. Therefore, on an average, approximately 35% of GAIL CSR Project's beneficiaries are from OBC community."



**PART II****OBSERVATIONS/RECOMMENDATIONS****Representation of OBC in the Board of Directors of GAIL**

1. The Board of Directors of GAIL consists of a Chairman & Managing Director, 06 full time Directors, 02 part-time Directors (Government nominee) and 08 part time non-official Directors (Independent). At present, 04 positions of Directors {01 full time, 01 part time and 02 part-time non-official Directors (Independent)} are vacant. The Committee express its concern that there is no representation of OBC category in the Board of Directors of GAIL. The Committee acknowledge that appointment of Directors in the Board of Directors of GAIL is decided by the Public Enterprise Selection Board (PSEB), Department of Public Enterprises, Government of India. There may not be any provision for reservation in Board of Directors, still the Committee feel that it is imperative to give due representation to OBCs for sake of social inclusion in the Board of Directors in GAIL. However, the Ministry is hopeful to find suitable candidates from OBC category to give due representation to OBCs while filling up remaining 4 vacant positions in the Board of Directors of GAIL in near future. The Committee, therefore, recommend that the Ministry of Petroleum and Natural Gas take up the matter at appropriate level so as to ensure representation of OBCs in the Board of Directors of GAIL.

**Reservation in recruitment in GAIL**

2. Though GAIL is implementing reservation policy for OBCs since 08.09.1993, yet the Committee are concerned to note that there were only 1143 employees belonging to OBC category as on 30.4.2022 out of total number of 4789 employees constituting just 23.86% of the total number of employees. Overall representation of OBCs in GAIL is much below the mandated percentage of 27% in employment. In Group 'A' service, the representation of OBCs is 21.05 per cent; in Group 'B', 30.42 per cent; in Group 'C', 35.73 per cent and in Group 'D', 27.90 per cent. The Committee appreciate that percentage of OBC representation in Group 'B', 'C' and 'D' is above the prescribed mandate of 27%

reservation for OBCs in employment. However, in Group 'A' percentage of OBC employees is 21.05 per cent which is below the prescribed 27% for OBCs in employment. Considering low representation of OBCs in overall strength and in Group 'A', the Committee recommend that the Ministry of Petroleum and Natural Gas take all necessary measures such as relaxing the standard for recruitment in favour of OBC candidates and initiating special recruitment drive to fill the backlog vacancies in group 'A' for OBCs in a time bound manner and ensure that overall representation of OBC does not fall short of the mandated 27% reservation in GAIL at any given point of time.

### **Backlog Vacancies and Special Recruitment Drives**

3. The Committee find that as on 31.12.2021, 24 number of backlog vacancies under Management Category (Group 'A') and 29 number of backlog vacancies under non-Management Category (Group 'B' and 'C') had been accumulated, which came down to 10 under Management Category through various recruitment/placement exercises/processes during the year 2021-22. However, no recruitment exercise could be initiated/carried out in respect of non-Management Category due to the restrictions placed on conducting these examinations physically during the Covid-19 pandemic. Though the remaining unfilled backlog vacancies will be filled-up during the Special Recruitment Drive (SRD) of 2022-23, as informed by the Ministry, yet the Committee still desire that unfilled backlog vacancies be filled up on priority basis in order to afford employment opportunities to deserving OBC candidates at the earliest.

### **OBC Employees' Welfare Association**

4. The Committee are of the opinion that OBC Employees ' Association can be an effective forum to take up issues relating to the recruitment, welfare and grievances of OBCs within the organization. The Committee, therefore, desired that management of GAIL may work in coordination with the OBC Employees' Welfare Association once formed for redressal of grievances of OBC Employees of GAIL.

### **Human Resource Training**

5. The Committee are pleased to note that in the area of Human Resource Development, GAIL has organized competency and capacity building programmes for its 21,884 (including 4,823 OBCs) employees within India and 521 (including 94 OBCs) employees outside India thereby enhancing the skills of their employees for achieving higher productivity and efficiency in the organization. The Committee hope that in future also due consideration will be given to OBC employees while selecting employees for sponsorship in various training/skill development programmes, in accordance with the extant guidelines of the Government of India in this regard.

### **Liaison Officer for OBCs**

6. The Committee note that Liaison Officers for OBC employees have been nominated at Corporate level as well as at regional/project level to enable the latter to come forward with their grievances and complaints, if any, without any hesitation along with enforcement of the reservation policy and other welfare measures. The Committee find that out of the total 12 officers nominated as Liaison Officers at regional levels, only 03 officers belong to the OBC category. The Committee, therefore, recommend that all those Liaison Officers, other than the OBC category, be replaced by Liaison Officers from OBC category only forthwith so that the interests of OBC employees can be safeguarded.

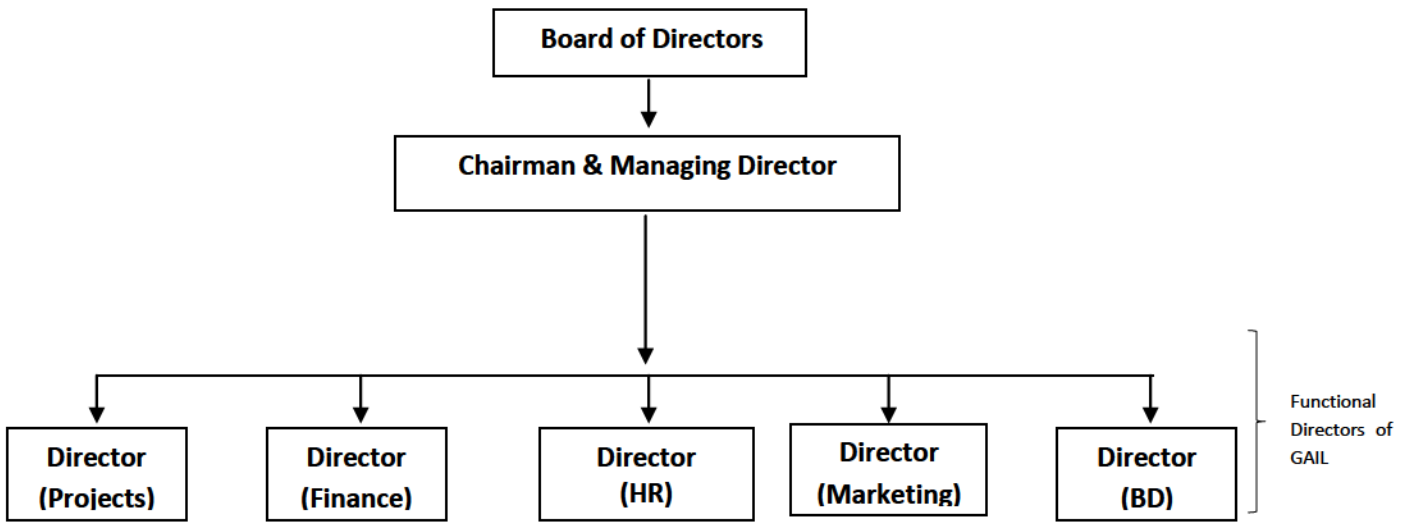
### **Corporate Social Responsibilities**

7. The Committee note that GAIL undertakes CSR activities as per the guidelines issued by Ministry of Corporate Affairs and Department of Public Enterprises (DPE). During the evidence, the representatives of GAIL affirmed that most of their projects are located in backward regions and inaccessible areas where majority of the inhabitants belong to SC, ST and OBC categories. The Committee were informed that GAIL has been running some Skill Development Centres also to impart skill trainings to the children of the families living in these backward regions. It is worthwhile to mention here that even in metro cities like

Delhi, Mumbai, etc., a sizeable population has been living on the outskirts or even at various central places within these cities who have migrated from States like Bihar, Madhya Pradesh, Rajasthan and other places who are socially and educationally backward. Since a majority of them come to these metro cities for their livelihood and sustaining themselves and probably have no resources to even fulfill basic needs of their children, some help should be extended to them. The Committee, therefore, recommend that Skill Development Centres be opened in metro cities also so that various basic skill trainings may be imparted to the children of socially and educational backward families thereby enabling them to earn their livelihood in the future.

2. At the outset, the Chairperson welcomed the Members of the Committee to the sitting of the Committee convened for taking evidence of the representatives of the Ministry of Petroleum & Natural Gas and Gas Authority of India Limited (GAIL) on the subject "Measures undertaken to secure representation of OBCs in employment and for their welfare in Gas Authority of India Limited (GAIL)". Thereafter, the representatives of Ministry of Petroleum & Natural Gas and GAIL were called in and Chairperson

welcomed the witnesses. The Chairperson desired the Ministry to apprise the Committee regarding the status of reservation for OBCs in employment and their welfare in GAIL. The Chairperson also emphasised the need for proper implementation of reservation policy for OBCs for all posts in GAIL. The representative of GAIL made a brief power point presentation to the Committee on the subject.

3. Thereafter, Chairperson and Members of the Committee raised various issues regarding implementation of OBC reservation policy and welfare measures undertaken for OBC employees in GAIL. Accordingly, the representatives responded to the major points given below:

- I. Implementation of 27% quota reserved for OBCs in all categories of posts in GAIL;
- II. Constitution of an OBC Welfare Association in GAIL and timeline of its formation to be provided to Committee;
- III. Representation of OBC employees in foreign training programmes organised by GAIL;
- IV. Proposal for providing compassionate appointment to the children/next of kin of employees died during the COVID-19 pandemic;
- V. Efforts made for the filling-up backlog vacancies in respect of OBCs;
- VI. Optimum utilisation of CSR funds for the welfare of OBCs, especially in remote areas;

- VII. Areas of developmental activities adjacent to a GAIL plant/unit be enhanced so as to cover more people from the backward regions;
  - VIII. Since migration from hinterland parts of India takes place in metro cities like Delhi, majority of them belongs to weaker sections of society, it was suggested for opening of Skill Development Centres in Delhi;
  - IX. Apart from OBC certificates (NCL) in English language, need for preparation and acceptance of OBC certificates printed in vernacular languages by concerned Government Organisations; and
  - X. Representation and compilation of data, if possible, pertaining to OBCs engaged through outsourcing and contractual labour.
4. The Chairperson directed the representatives of the Ministry and GAIL to furnish written replies to the queries which were not responded to by them during the sitting or on which the requisite information was not readily available with them, to the Committee at the earliest.
