- (a) & (b):** A total Capital Investment Subsidy of Rs. 1,066.66 crore has been released in 4,235 cases under Amended Technology Upgradation Fund Scheme (ATUFS) in last three years (2019-20 to 2021-22). In addition, a total of Rs. 429 crore has been disbursed as Interest Reimbursement/ Margin Money Subsidy under the committed liabilities of old versions of TUFS, making the total release under ATUFS during last three years as Rs. 1,495.66 crore across the country. Detail of support provided to textile units in Uttar Pradesh, Madhya Pradesh, and Maharashtra under ATUFS in last three years is given in Annexure-I
- (c):** A total of 821 energy saving machines have been incentivized under ATUFS since 2016.
- (d):** Segment wise and year wise details of subsidy released under ATUFS including weaving, processing and garment sector since 2015-16 till 2022-23 is given in Annexure II.
- (e):** Year-wise details of subsidy released to the units in the State of Uttar Pradesh, Madhya Pradesh, and Maharashtra since 2015-16 is given in Annexure-III.
