com-1951-52, grain and other modities bought at a total cost of Rs. 17,97 lakhs were sold for Rs. 9,48 lakhs. The percentage of loss over cost price in 1951-52 was 57.

All the figures for 1951-52 are inclusive of the ex-States Railways but are approximate as the actual figures for the last 3 months are not readily available

P. AND T. OFFICES IN PUNJAB AND HIMACHAL PRADESH

230. Shri Hem Raj: Will the Minister of Communications be pleased to state:

- (a) the number of post and telegraph offices opened in the years 1950-51 and 1951-52, district-wise, in the States of Punjab and Himachal Pradesh:
- (b) how many of them were opened in urban areas and how many in rural areas:
- (c) the extent of the area and the number of the population which they are serving;
- (d) how many post offices Government propose to open in these States during the year 1952-53; and
- number is allotted (e) what urban and what to rural areas, districtwise?
- The Deputy Minister of Communications (Shri Raj Bahadur): (a) and (b). A statement giving the information is placed on the Table of the [See Appendix V, annexure House. No. 56.]
- (c) Information about the area served by the new offices is not readily available. In regard to population, it is expected that the new P. and T. offices will benefit roughy over 6 lakhs. of people in the Punjab and over half a lakh in Himachal Pradesh.
- (d) and (e). No numerical target has been fixed. In rural areas, there are now no villages in the States of Punjab and Himachal Pradesh with a population of 2,000 or more that remain to be provided with post offices.

GOVERNMENT SERVANTS CONDUCT RULES

- 231. Sardar Lal Singh: Will the Minister of Home Affairs be pleased to state:
- (a) whether Government are considering revision of Government Servants Conduct Rules to bring them in consonance with the provisions of the Constitution of India;

- (b) if the reply to part (a) above is in the affirmative, whether approval of the Parliament will be taken before their promulgation; and
- (c) if the reply to part (a) above be in the negative, the reasons therefor?

The Minister of Home Affairs and States (Dr. Katju); (a) Yes, Sir.

(b) and (c). Revised rules will be made by the President under the proviso to article 309 of the Constitution which does not require the approval of Parliament. However, copies of the revised rules will, when published, be supplied to the Library of Parliament and also placed on the Table of the House.

CIVIL SERVICES (CLASSIFICATION, CON-TROL AND APPEAL) RULES

- 232. Sardar Lal Singh: Will the Minister of Home Affairs be pleased to state:
- (a) whether Government are con-(Classification, Control and Appeal)
 Rules in view of provisions of the
 Constitution of India; and
 (b) if control and Appeal)
- (b) if so, when such amendments will be promulgated?

The Minister of Home Affairs and States (Dr. Katju): (a) Yes, Sir.

(b) The formulation and implementation of a number of Service Organization Schemes is now in progress. The final classification of the Services and the specification of controlling authorities can only be done after this work has been completed. As regards rules relating to disciplinary proceedings, the hon. Member's attention is invited to the answer given by me to the Unstarred Question No. 96 on the 5th June, 1952. For these reasons it is not possible to give a definite reply to this part of the question.

DIBIAPUR-PHAPHUND RAILWAY LINE

- 233. Shri Badshah Gupta: Will the Minister of Railways be pleased to state:
- (a) whether it is a fact that there was a scheme under the contemplation of Government to connect Etawah, Mainpuri and Etah Districts by con-structing a new Railway line from Dibiapur-Phaphund in Etawah District to Mainpuri and Etah;
- (b) what is the present position of the scheme: and
- (c) whether any survey operations were undertaken in this connection?

The Minister of Railways and Transport (Shri L. B. Shastri): (a) and (b). Yes. The Uttar Pradesh Government recommended a rail connection between Phaphund and Bulandshahr, via Mainpuri, Etah, Kasganj, Debai and Anupshahr. This scheme was considered and dropped by the Central Board of Transport.

(c) No survey operations were undertaken for the project.
