### Bodies of Newly Born Babies

(a) whether it is a fact that Delhi Police found the bodies of three newly born infants on the 13th February, 1964 in Delhi without claimant; and

(b) if so, the steps Government propose to take for the protection of such new born children?

**The Minister of State in the Ministry of Home Affairs (Shri Hathi):** (a) No, Sir. Only one dead body of a newly born male child was found on the said date.

(b) such newly born children, if found alive, are admitted in the Foundling Home, Nangia Maternity Home, Shakti Nagar, Delhi, managed by the Government.
