

(c) the steps taken by the Railway authorities in the matter?

The Minister of Railways (Shri C. M. Poonacha): (a) to (c). Yes. It has been reported that on 31st May, 1967 at 23-45 hours on receipt of information from Station Master, Dum Dum Cantonment Station about theft near the Outer Signal, the Inspector, Railway Protection Force, Sub-Inspector, Government Railway Police proceeded to site and recovered three bags of wheat. When the party were carrying the recovered bags of wheat towards Dum Dum Cantonment Station, they were fired upon by State Armed Police personnel posted to guard nearby wireless station, alleging that wheat bags were being carried after stealing them from a train. Railway Protection Force/Government Railway Police party who were in proper uniform stopped and shouted back that they were Railway Protection Force and Police personnel but State Armed Police personnel who were in mufti continued to fire at random. Thereupon, the Inspector, Railway Protection Force had to fire in self-defence, but they were overpowered, assaulted mercilessly causing severe injury on the persons of the Inspector, Railway Protection Force, Sub-Inspector, Government Railway Police and a Rakshak, Railway Protection Force, and were dragged towards the State Armed Police camp. On getting the information 2 Sub-Inspectors from Dum Dum Police Station came to the State Armed Police Camp and rescued the Inspector, Railway Protection Force and his party.

Government Railway Police, Sealdah, have registered two counter cases, one under Section 332/307 I.P.C. against State Armed Police personnel and the other under Section 307 I.P.C. against Railway Protection Force and Government Railway Police personnel. Inspector General of Police, West Bengal has also been approached for a high level enquiry into the incident.

Tea Gardens
