(b) if so, the decision taken thereon ?

(a) Yes.

(b) The request of the Madhya Pradesh Government has been considered carefully but due to acute shortage of general pool accommodation for eligible Central Government servants it has not been possible to spare general pool residential accommodation for allotment to the employees of Madhya Pradesh Government stationed at Delhi. Incidentally, the Government of Madhya Pradesh has no such reciprocal arrangements either, with the Central Government.
