## खिलौना उद्योग

3611. श्री कचर लाल हेमराज जैन: क्या वाणिज्य तथा नागरिक पूर्ति ग्रीर सहकारिता मंत्री यह बतानें की कृपा करेंगे कि:

- (क) खिलौना उद्योग में काम करनेवाले श्रमिकों की संस्था कितनी है ;
- (ख) क्या ग्राल इंडिया हैंडिकाफट्स बोर्ड ने चाबी से चलने वाले खिलौनों, पी० बी० सी० निर्मित गुड़ियां तथा विविध प्रकार के खिलौनों के निर्माताग्रों को मान्यता नहीं दी है ग्रौर इन्हें हैंडीकाफट की श्रेणी में शामिल नहीं किया गया है; ग्रौर
- (ग) यदि हां, तो खिलौना उद्योग की प्रगति, विकास स्रौर संरक्षण प्रदान करने के लिए वया उपाय कियी जा रहे हैं?

बाणिज्य तथा नागरिक पूर्ति ग्रौर सहका-रिता मंत्री (श्री मोहन धारिया): (क) विभिन्न प्रकार के परम्परागत ग्रौर ग्राधु- निक खिलौनों का उत्पादन विविध प्रकार के बहुत से प्रतिष्ठानों में हो रहा है, जैसे कि कुटीर तथा ग्राम उद्योग, लघु एकक, ग्रौर इनमें ग्राधुनिक फैक्टरी-टाइप प्रतिष्ठान भी शामिल हैं। इन सभी प्रतिष्ठानों में काम कर रहे व्यक्तियों की सही संस्था ज्ञात नहीं है।

## Foreign Exchange Manipulations by Singhanias

3612. SHRI JYOTIRMOY BOSU: Will the Minister of FINANCE AND REVENUE AND BANKING be pleased to state:

- (a) some members of the Singhania family at Calcutta, Kanpur and other places had been very recently found involved in foreign exchange racket;
- (b) whether some members of the family particularly Gaur Hari Singhania, Bharat Singh Singhania were involved in serious invoice manipulation and other foreign exchange rackets; and
- (c) if so, action taken by Government?

THE MINISTER OF FINANCE AND REVENUE AND BANKING (SHRI H. M. PATEL): (a) No member of Singhania family at Calcutta, Kanpur and other places had been found involved in foreign exchange racket during the last one year.

Particulars of contraventions of Foreign Exchange Regulation Act, if any, punishable under the Customs Act, by the members of the Singhania family during the last one year, are being collected and will be laid on the Table of the House.

(b) and (c). The Directorate of Enforcement had issued Show Cause Notices for violation of certain provisions of Foreign Exchange Regulation Act in three cases against two Companies and its Directors and Export Manager. Some members of the Singhania family are Directors in the above two companies. Shri Bharat Hari Singhania is a Director of one of these Companies and he was a Director of the other Company upto 11th February, 1971.

The Directorate of Enforcement had also issued Show Cause Notice for violation of certain provisions of Foreign Exchange Regulation Act against a partnership firm in which three members of the Singhania family are partners.

All the four cases have been adjudicated by the Directorate of Enforcement. Two cases have ended in acquittal. In the other two cases one of the companies involved has been found guilty of certain charges and penalties of Rs. 6.5 lakhs and Rs. 1.75 lakhs have been imposed in the two cases. In these two cases the Export Manager of the Company has also been found guilty of certain charges and penalties of Rs. 65,000 and Rs. 17,500 have been imposed on him. Charges against others have been dropped.

In November, 1974, the Commissioner of Police, Calcutta had issued detention orders against Shri Bharat Hari Singhania on the basis of the
