THE MINISTER OF COMMERCE AND CIVIL SUPPLIES AND CO-OPERATION (SHRI MOHAN DHA-RIA): (a) to (d). There is no apparent relationship between the contraction in total trade and change in the Government.

The latest provisional official data regarding foreign trade is for the period April-May, 1977. As compared with the same months of 1976. exports from the country were larger by 4 per cent and imports were smaller by 17 per cent. The country wise details of foreign trade are not available.

It is the policy of the Government to expand, improve and promote trade with all countries. For this purpose a number of steps have been taken which include setting up of joint economic commissions, participations in trade fairs and exhibitions abroad. identification of areas and export items with export potential and other export promotion measures like duty drawback, cash compensatory support, provision of export finance, quality control and supply of imported and domestic inputs.
