**CBI Investigation on Assassination of JMM Leader in Bihar**

(a) whether the Government of Bihar had requested the Union Government to get the assassination case of the Ex-President of the Jharkhand Mukti Morcha, Late Nirmal Mahto investigated by the Central Bureau of Investigation;

(b) if so, the action taken thereon; and

(c) the progress made in the investigation of the case so far?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M.M. JACOB): (a) Yes, Sir.

(b) and (c). Investigation of this case was completed by the Central Bureau of Investigation and a charge sheet filed in the Court against the accused.

**Amendments to Official Secrets Act**

(a) whether there is any proposal to amend the Official Secrets Act;

(b) if so, the details thereof; and

(c) when it is likely to be amended?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M.M. JACOB): (a) to (c). There has been a proposal to carry out certain amendments to the Official Secrets Act, 1923 which are generally aimed at making the relevant provisions more liberal to provide treated access to official information. In view of the importance and complexity of the subject, formulation of definite views on the issues involved in the matter, would necessarily take time.

**Activities of U.K. Nationals**

(a) whether attention of the Government has been drawn to the news-item captioned "What were the two Britons doing in North-East?" appearing in the Indian Express dated February 14, 1992;

(b) if so, the facts of the case; and

(c) the reaction of the Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M.M. JACOB): (a) Yes, Sir.

(b) Two British nationals namely David Ward and Stephen Hillman entered Nagaland unauthorisedly and without the necessary travel documents in November, 1991. They were found organising meetings in Nagaland and indulging in virulent subversive anti-India propaganda. On 30th January, 1992, they were arrested along with the 13 nagas under the National Security Act by the Security Forces after an exchange of fire in which one Naga died. Some chinese made LMG and Rifles, ammunitions, one Videocamera with cassettes etc., were recovered.

(c) A case was registered under the Meluri Policy Station and the investigation entrusted to the Central Bureau of Investigation.
