THE MINISTER OF STATE OF THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z.R. ANSARI) : (a) and (b). The estimate alongwith the proposal for construction of road-over-bridge has been received in the Ministry from the State Government and is under examination.

Scheme for widening and strengthening of Chunakhali-Jalangi Road under strategic road programme

4719. SHRI ZAINAL ABEDIN : Will the Minister of SHIPPING AND TRANSPORT be pleased to state :

(a) whether it is a fact that a Scheme for widening and strengthening of the Chunakhali-Jalangi Road connecting a good number of border outposts of vital importance in the District of Murshidabad has been submitted by the Government of West Bengal to the Union Government for inclusion under the strategic road programme ;

(b) if so, the details thereof ; and

(c) the reaction of Government thereto ?

THE MINISTER OF STATE OF THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z.R. ANSARI) : (a) and (b). Yes, Sir. A proposal for inclusion of the scheme for widening and strengthening of Chunakhali-Jalangi Road from 0 km to 48 km of SH 11 in the District of Murshidabad under the strategic road programme during 1985-86 has been received from West Bengal Government.

(c) On examination it has been found not necessary to include this scheme under the Strategic Road Programme.

Flood forecasting

4720. SHRI ZAINAL ABEDIN : Will the Minister of IRRIGATION AND POWER be pleased to state :

(a) whether it is a fact that the Central Water Commission is engaged in

the collection, analysis and dissemination of hydrological observation data and flood forecasting ;

(b) if so, what are its performance during the last three years so far as flood forecasting is concerned, year-wise details ; and

(c) what is the performance of its Eastern Division during the same period ?

THE MINISTER OF IRRIGATION AND POWER (SHRI B. SHANKARANAND) : (a) The Central Water Commission is engaged in collection, analysis and dissemination of hydrological observation data and flood forecasting on inter-State flood-prone rivers.

(b) and (c). The number of flood forecasts issued during the last three years for the country as a whole and for the Eastern Division are :

New Railway Station at Umroli

(a) whether Government are considering to establish a new Railway Station at Umroli (Western Railway) between Palghar and Boiser (Western Railway) ;

(b) if so ; when ; and

(c) if not, the reasons therefor ?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA) : (a) No, Sir,

(b) Does not arise.

(c) The proposal for opening of halt station at Umroli between Palghar and Boiser stations was examined by Western Railway but not found financially justified.

Mobile booking system in Suburban section of Bombay

4722. SHRI ANOOPCHAND SHAH : Will the Minister of RAILWAYS be pleased to state :

(a) whether Government are considering to restart mobile booking system in Suburban section of Bombay to avoid inconvenience to commuters ;

(b) if so, when ; and

(c) if not, the reasons therefor ?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA) : (a) No, Sir.

(b) Does not arise.

(c) The working of the system was not found satisfactory. Alternative methods of opening additional counters and/or installing Self Printing Ticket machines are being employed to the extent feasible, to relieve rush at booking windows.

Social Forestry Courses in educational Institutions

4723. KUMARI PUSHPA DEVI : Will the Minister of EDUCATION be pleased to state :

(a) whether Government have a proposal to introduce a course on Social Forestry in the curricula of educational institutions ;

(b) whether guidelines are proposed to be sent to the State Governments to introduce such courses ; if so, the details thereof ;

(c) whether some State Governments like Madhya Pradesh have initiated efforts

to popularise social forestry programmes in schools ; and

(d) if so, the assistance proposed to be given by the Centre to such State Governments ?

THE MINISTER OF EDUCATION (SHRI K. C. PANT) : (a) to (d). School Education is primarily the responsibility of the State Governments and is mostly looked after by them. State Governments and State Boards of Secondary Education are responsible for prescribing the curricula, syllabi and textbooks at all levels. The Government of India agrees that social forestry is an important subject to which students must be adequately exposed and measures are being taken to strengthen its education in schools but academically it would not be appropriate to introduce a new subject in schools on social forestry in view of the already heavy curriculum. The curriculum prepared by the NCERT highlights the importance of forests in everyday life. Various aspects of Forestry already form a part of environmental education presently being taught in schools and has been included in existing subjects like Social Science, Geography, Biology, etc.

The States are free to adopt/adapt the NCERT curriculum. Academic support through NCERT would be provided to all states including Madhya Pradesh, wherever it is required.

Health Guides in Madhya Pradesh

(a) whether Government have a proposal to appoint more Health Guides during the current financial year ;
