Effect of Nationalisation of LLS.Co.

THE MINISTER OF STEEL AND MINES (SHRI BIJU PATNAIK) (a) and (b) The management of company was taken over by the Central Government in 1972, initially for a period of two years, which was extended subsequently by three years In view of substantial investment required by the company from Government to make it a viable unit, it was decided that the ownership the company should vest in Government. Accordingly, the shares of the company held by parties other than the State Governments and public sector institutions were acquired by legislation with effect from 17th July

There has been steady improvement in the production performance of the company since July, 1972. The capacity utilisation, in terms of saleable steel has gone up from 43 4 per cent in 1972-73 to 67.8 per cent The targetted production 1976-77 for 1977-78 is 068 million tonnes of saleable steel which if achieved would represent a capacity utilisation of 85 per cent.

Written Answers

- (c) The following measures have been taken or are proposed to be taken to improve the economic viability of the company -
 - (1) A plant rehabilitation scheme at a cost of Rs 61 crores is being implemented to restore the capacity of the steel plant to its rated level. About 85 per cent of the scheme has been completed,
 - (11) Certain other capital schemes cost about Rs 425 estimated to crores over the next ten years, have also been undertaken for increased production and sustained production.
 - (III) The technology used present in the steel plant for manufacture of iron and steel is outdated Schemes for modernisation of iron and steel-making facilities are being formulated.
 - (iv) It has been decided that in order to ensure a coordinated development of the company and to make for better management of its technological, production and financial problems, the shares presently held by the Central Government in this company should be transferred to Steel Authority of India Ltd (SAIL) when it would become a subsidiary of Sail It is also proposed to acquire the shares held by the public financial institutions others and to transfer them to SAIL so that IISCO, can become a Division of SAIL, after the organisation of SAIL has been re-structured

(b) It is true that due to strikes in the explosives factory at Goinia and the Washeries at Dugda and Bhojudih as also power shortages, coal gupplies to the steel plant during October 77 were adversely affected tide over the shortages the steel plant accepted higher proportion of medium/ blendable coals and regulated coke oven pushings With the strike in the Dugda and Bhojudih Washeries having since been called off and some production of explosives at Gomia resumed, the situation is showing signs of improvement A close watch is however being maintained in consultation with the coal companies.
