## Construction of Dykes on Coastal Areas to check Tidal Havoc

5313. SHRI K. A. RAJU: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

- (a) whether there is any proposal with the Government of India to construct high dykes in the low lying coastal areas of Bay of Bengal in Tamil Nadu and Andhra Pradesh to avoid recurrence of recent cyclonic havo; and
- (b) if so, what is the estimated cost for the construction of dykes?

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) The Government of India have no proposal to construct high dykes in the costal areas! of Tamil Nadu and Andhra Pradesh to prevent flooding on account of tidal waves during cyclonic storms. However, at the request of the Government of Andhra Pradesh, model experiments for fixing up top level and protection works for costal embankments on Kona Block and Divi Island have been taken up by the Central Water and Power Research Station, Pune.

The Working Group set up by Government for formulating Central Schemes of Physical Education and Sports for inclusion on in the Sixth Five Year Plan has recently recommended inter-alia a new scheme of setting up some sports hostels in selected Kendriya Vidyalayas in different regions in the Country as well as in other selected centres in the States/Union Territories. The recommendations of the Working Group will be considered by Government in the context of the funds likely to be available for fresh Central Schemes of Physical Education and Sports in the Sixth Plan.
