- (iv) Prior to 1948, turniture was provided for Service Officers by the M.E.S. only at those stations where hiring from the market was either impossible or expensive. Government have now assumed responsibility of providing furniture for service officers at all military stations and suitable scales have been prescribed for the purpose;
- (v) Electric lighting is authorised for living accommodation for service personnel of all ranks at all stations. JCOs, Havildars and Other Ranks are authorised to use free of charge electric fans already installed in barracks and other buildings vacated by British troops. Such fans will be maintained and replaced by the MES when worn out.

Navu

Efforts are constantly made to effect improvements in the living conditions both ashore and afloat, within the limitations of service requirements, e.g., on ships the essential equipments take up a good amount of space, leaving little room for living quarters.

Air Force:

The Government are providing accommodation to the I.A.F. personnel as far as possible. Recreational facilities and welfare amenities are also provided.

The amounts vary from year to year. The following amounts will give an idea of the expenditure on welfare schemes during the year 1952-53:—

(iv) Canteen Profits—Army HQ and HQ Commands.

Navy: Commanding Officers of the Ships and Establishments.

Air Force: Officers Commanding of Units assisted by Welfare Committees.

(e) In the Army, the planning and execution of welfare matters is done by the units themselves. All ranks are consulted in unit darbars. These darbars are a regular feature of Army life, at which all ranks are free to offer observations, make suggestions and represent any matters. In the other two Services representation is given by election.
