(d) What was the income from the private manufactures' stalls etc?

The Deputy Minister of Rallways and Transport (Shri Alagesan): (a) Practically all the models and exhibits displayed in the Indian Railways' Pavilion and other Railway stalls are of a permanent character.

- (b) Most of the models have been selected for exhibition on the Metre Gauge and Broad Gauge Exhibition Trains which are now going round the country. All other models have been returned to the Railways concerned, who have been instructed to keep them in good order.
- (c) No dismantlement of the pavilions has taken place. The Ministry of Works, Housing and Supply propose to use the pavilions in connection with the International Exhibition on Low Cost Housing to be held in January 1954. The materials used in the building and the pavilion are ordinary platform shed material and are fully re-usable
- (d) The income by way of rental from private stall holders, amusement park and refreshment contractors, hoarding sites, etc. is approximately Rs. 4.5 lakhs.

In addition, the construction of Teakiosks as Kottavalasa and Pendurti has also been included in the Railway's Works Programme for 1954-55.

As regards the Parlakimedi Light Railway Section, there are no catering or vending arrangements at present but construction of Tea kiosks at Tekkali and Gunupur has been included in the Railway's Works Programme for 1954-55. There are no alternative arrangements for catering and vending in this Section at present. A system of train vending had been introduced as an experimental measure prior to 1-7-1951, but it was a failure, Efforts had been

made to start station vending at Tek-kali. Ganguvada. Parlakimedi, Varanasi and Gunupur. Initially no contractor was prepared to accept these contracts. Subsequently, a contractor was pursuaded to make vending arrangements at these stations. But the service rendered by him was reported to be extremely unsatisfactory and these vending arrangements had to be stopped.

The only representation received in this connection is a very recent one dated 14-7-1953 for a tea stall at Parlakimedi which is under the Railway's consideration.
