The Minister of Defence Organisation (Shri Tyagi): (a) Yes.

(b) The Government of India's policy was to integrate only regular Indian State Forces with the Indian Army. As the Mewar Bhil Corps was an irregular force it was not integrated with the Indian Army.

TERRITORIAL ARMY

- 692. Shri Bheekha Bhai: Will the Minister of Defence be pleased to state:
- (a) whether Government have set up Advisory Committees in the States for raising the territorial army; and
- (b) if so, how the Members of the Advisory Committees are appointed?

The Minister of Defence Organisation (Shri Tyagi): (a) We wrote to the State Governments in April 1953 suggesting the desirability of setting up Advisory Committees, on the lines of the Central Advisory Committee, to encourage recruitment and to consider any local problems regarding the Territorial Army. Such Committees have been or are on the point of being set up in Madhya Pradesh, Orissa, West Bengal and Bombay. Proposals from other State Governments are awaited.

(b) The State Advisory Committees are formally constituted by the Central Government on the recommendation of the State Government concerned. Generally speaking, the Chief Minister. is the Chairman and local Military Commander is one of the members, and an Army officer functions as the Secretary of the Committee. A statement giving the composition of the State Advisory Committees for Madhya Pradesh, Orissa, West Bengal and Bombay is placed on the Table of the House. [See Appendix VI, annexure No. 39.]
