- (b) if so, whether there is separate list for Grade I Officers; and
- (c) when the Departmental Promotion Committees is going to meet for the selection for the posts of Director General, Health Services and Additional Director-General Health Services?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI NIHAR RANJAN LASKAR): (a) and (b) Yes. There are separate seniority lists for different grades of Central Health Services Officers.

(c) Meeting of the Departmental Promotion Committee for these two posts is to be held shortly in consultation with the U.P.S.C.
