Export of foodgrains by Necf

4590. SHRI JYOTIRMOY BOSU: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether it is a fact that National Cooperative Consumer Federation wil expert about 1.50 lakh tonnes of foodgrains to other countries;
 - (b) if so, the details thereof;
- (c) whether Government are aware that there is an overall shotafall of about 20 million tonnes of foodgrains this year;
- (d) whether Government consider that this export will aggravate shortages which can create serious shortages in the country; and
 - (e) if so, the action taken thereof?

THE MINISTER OF STATE MINISTRY OF AGRICUL-TURE AND RURAL RECONSTRUC-TION (SHRI R V.SWAMINATHAN) (a) and (b). It is a fact that National Cooperative Consumer's Federation Limited has been authorised by the Ministry of Commerce to export 53,000 tonnes of non-basmati rice.

(c) to(e). During the year 1979-80 the production of foodgrains has been estimated at 108.9 million tonnes which indicates a shortfall of about 23 million tonnes as compared to the preceding year.

Firm estimates of production during the year 1980-81 are not yet available. The outlook for agricultural production in the country is quite encouraging and it is anticipated that the production of foodgrains during 1980-81 may be somewhat higher than the record level achieved in 1978-79. Rice other than basmati is allowed to be exported only in limited quantities after providing for our own domestic requirements.
