Air Pollution in Vivek Vihar

3045. KRISHAN PARTAP SINGH: Will the Minister of WORKS AND HOUSING be pleased to state:

- (a) whether his attention has been invited to a news-item which appeared in 'Indian Express' dated the 22nd August, 1981 under the heading 'Air Pollution in Vivek Vihar';
- (b) whether it is a fact that the tyre manufacturing unit in Jhil Mil Taharpur Industrial Area is using rubber scrap instead of furnace oil leading to emission of columns of smoke full of particles of rubber day and night; and
- (c) the steps taken or propose to be taken by the Government to give relief to the residents of the area?

THE MINISTER OF PALIA-MENTARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH): (a) Yes, Sir.

- (b) According to the inspections carried out during day time by the Delhi Smoke Nuisances Commission set up under the provisions of the Bombay Smoke Niusances Act, 1912, as extended to the Union Terrtirory of Delhi in the months of January 1981, February, 1981, April, 1981, May, 1981, June, 1981 and August, 1981, the smoke emitted by M/s. Sawhne/ Rubber Industries situated in Jhil Mil Industrial area was found within the permissible limits as prescribed in the rules framed under the Act.
- (c) The Delhi Smoke Nuisances Commission, set up under the provisions of the Bambay Smoke Nuisance Act 1912, as extended to the Union

Territory of Delhi, is functioning to check the smoke nuisance in Delhi.

Pollution in Dal Lake in Srinagar

- (a) whether Government are aware that the Dal Lake of Srinagar has been subject to highest rate of pollution in the country;
- (b) if so, the extent of pollution and its effect on the health of persons taking use of this one; and
- (c) the steps proposed to be taken by Government to keep the Lake free from pollution and also to reduce the extent of pollution?

THE MINISTER OF PAR-LIAMENTARY AFFAIRS AND WORKS AND HOUSING (SHRIBHISHMA NARAIN SINGH):
(a) Government is aware of the pollution of Dal Lake.

- (b) Government is not aware of the precise extent of effect on the health of persons. It is, however, sure that use of polluted water adversely affects the health of persons.
- (c) The Government of Jammu & Kashmir is seized of the problem of pollution in Dal Lake and has launched a scheme for protection and preservation of the lake within an area of 19 sq. K.M. in a phased manner. Phase I, which is under execution at present, aims at prevention of encroachments and abatement of pollution and comprises, bounding the lake on all sides by a circular road system, replanning of house boats and their waste disposal, improvements to the catchment area of the lake, selective deweeding, marginal dredging and construction of a settling basin to remove sediments of the in flow and the construction of a number of water regulator structures to help in flushing out of nutrients.
