- (c) whe her's ch internal trading is permissible to the foreign subsidiaries under FERA;
- (d) whether any action has been taken against the relinquent management of this company in this regard; and
- (c) whether Himlustan Lever is still persisting with such practices under the cover of newly coined words like 'Processed Triglycerides'?

THE DEPUTY MINISTER IN THE MINISTRY OF CIVIL SUPPLIES SHRI BRAJA MOHAN MOHANTY: (a) Yes, Sir.

- (b) The raw materials used in the manufacture of vanaspati are imported oils allotted by the Government and indigenous oil purchased by the Vanaspati factory in the market. There is no evidence of the Company having diverted the imported oil allotted to it in the open market during 1974, nor has it admitted having done so.
 - (c) and (d). Do not arise.
- (e) This would be got looked into.

- (c) if so, on what consideration and the lit of persons to whom flats have been allotted in relaxation of the normal pre-cribed procedure of the D.D.A.?

THE MINISTER OF PARLIA-MENTARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH):

(a) The DDA has reported that the Chairman/Vice-Chairman can exercise their discretion in eciding such cases in view of the powers delegated to them by the Authority for making allotments on compassionate grounds.

(b) and (c). The DDA has reported that the Vice-Chairman normally condones the difference if the income of the registered person marginally exceeds or falls short of the lincome limit fixed for a particular category in which he is registered. The DDA has also reported that there is no such case during the year 1980-81.
