वित्त मंत्रालय में राज्य मंत्री (श्री सवाई सिंह सिसोदिया) : (क) हालांकि सरकार को कुछ सुझाव प्राप्त हुए हैं, पर फिलहाल ऐसी कोई योजना नहीं है।

(ख) सरकारी उद्यमों के कार्य निष्पादन में गिरावट के लिये प्रबंधकीय अक्षमता सहित अनेक कारण हो सकते हैं। उनमें प्रबंधकीय कार्यकुशलता बढ़ाने के उद्देश्य

से चयन, प्रशिक्षण और विकास का स्तर बेहतर बनाने के लिए विभिन्न सद्दुपाय किये गये हैं। सरकार द्वारा सरकारी उद्यमों के कार्यचालन की निरन्तर समीक्षा की जाती है ताकि उनकी क्षमियों का पता लगाया जा सके और सुधारात्मक कार्रवाई यथासमय की जा सके।

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI MAGANBHAI BAROT): (a) The names of the companies to whom the Industrial Development Bank of India and the Industrial Finance Corporation of India as on 30-6-81 and the Industrial Credit and Investment Corporation of India as on 30-9-81 had individually disbursed assistance of more than Rs. 5 crores are given in the attached statement.

(b) Government does not consider it proper to publicise the names of industrial concerns who are in default at a particular point of time as this may adversely affect their credit-worthiness in the market.
