## Road Over-bridge at Sambalpur Station

7265. SHRI CHINTAMANI PANI-GRAHI: Will the Minister of RAIL-WAYS be pleased to state:

- (a) whether any progress has been made so far, regarding the proposed road over-bridge at Sambalpur Station in South-Eastern Railways; and
- (b) if so, the details of the progress made by now?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIA-MENTARY AFFAIRS (SHRI MALLIKRJUN): (a) and (b). A proposal for construction of a road over-bridge in replacement of existing level crossing at Km. 558/11-12 on National Highway No. 6 near Sambalpur sponsored by the State Government is under the examination of the Railway, State Government and National Highway Authorities. The Railway sent

an estimate amounting to Rs. 17.82 lakhs for the bridge portion to the Superintending Engineer, National Highway, Sambalpur in March, 1982. The State Government is now required to prepare estimate for the approaches to the proposed road over-bridge and send the consolidated estimate to the Ministry of Shipping and Transport for sanction. The proposal will be considered for inclusion in the Railways Works programme as and when it is finalised and mutually accepted by the Railway and the State Government/Road Authorities.

## Running of Additional Shuttles between Daund-Pune-Daund and Pune-Satara-Pune.

7266, SHRI SHANKAR RAO PATIL: Will the Minister of RAIL-WAYS be pleased to state:

- (a) whether Government propose to run Daund-Pune-Daund and Pune-Satara-Pune additional shuttles to remove congestion of Passenger Traffic in that area; and
  - (b) if so, when?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIA-MENTARY AFFAIRS (SHRI MAL-LIKARJUN): (a) No. There is no congestion of passenger traffic on Pune-Daund and Pune Satara sections There are adequate train services on these sections.
