- (क) क्या देश की राजनीति, इतिहास ग्रीर सांस्कृतिक परम्परा में इलाहाबाद का महत्वपूर्ण स्थान है;
- (स) क्या इलाहाबाद को देश के दूर-दर्शन मानचित्र में ग्रभी तक कोई स्थान नहीं मिला है;
- (ग) क्या इलाहाबाद को देश के दूर-दर्शन मानचित्र में लाने का कोई प्रस्ताव है; और
- (घ) यदि हां, तो ऐसा कब तक किया जाएगा श्रीर यदि नहीं, तो इसके क्या कारण हैं?

(ग) श्रौर (घ) दूरदर्शन के विस्तार की भावी योजना के श्रन्तर्गत डाक-तार माइकोवेव लिंक की सहायता से दूरदर्शन रिले केन्द्र स्थापित करने के लिए 49 स्थानों में से एक स्थान इलाहाबाद चुना गया है जो दूसरे चरण (1985-90) में है। इस योजना का कार्यान्वयन संसाधनों की उप-लब्धता पर निर्भर करेगा।

Scavenging work in DESU entrusted to Contractors

- 347. SHRI R. N. RAKESH: Will the Minister of ENERGY be pleased to state:
- (a) whether the scavenging work at many places in DESU has been

entrusted to contractors; if so, the reasons therefor;

- (b) whether a decision to terminate the aforesaid contracts by 30 April, 1981 had been taken; if so, the reasons for its still continuing;
- (c) the reasons for recruiting labourers on daily wages instead of employing them from panel of scavengers and the number of such persons recruited after the formation of the panel;
- (d) the time by which recruitment would be made from the panel; and
- (e) the total number of posts of attendants in DESU and whether all the reserved posts have been filled up and if not, the reasons therefor and the number of posts to be filled up to complete the reserved quota?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN) (a) to (d). A decision was taken in April, 1981, to terminate contract system for scavenging work in DESU. This decision could be implemented partially since efforts to make alternative arrangements did not succeed at all places. A panel of 23 Safai Karamcharis was drawn up in March, 1980. Seventeen candidates have already been given employment. This panel is valid upto 14th March, 1982 and appointments will be made and when vacancies Workers are engaged on daily wages when the nature of work is casual and for brief duration, e. g. against leave vacancies in remote places and for part-time work. The number of. daily wage Safai Karamcharis as at present is 46.

(e) There are no posts of 'Attendants' in DESU and as such the question does not arise.
