**The Minister of Food and Agriculture (Shri A. P. Jain):** (a) Three.

(b) 330 acres are reserved for elephants in the Samusang Forest Reserve where about 200 acres would be fit for cultivation. Out of this area of 200 acres about 70 acres are under cultivation.

(c). No.

(d) The reserve has to continue till some suitable alternative land for the elephants is found. De-reservation of the land for settlement is not possible for the present.

#### **Cudappa-Kurnool Canal in Andhra**

**1408. Shri Rami Reddy:** Will the Minister of Irrigation and Power be pleased to state:

(a) whether the Andhra Pradesh Government has requested for additional financial assistance for the development of Ayacut under the Cudappa-Kurnool Canal and Rajolibunda; and

(b) if so, the amount sanctioned as assistance?

**The Deputy Minister of Irrigation and Power (Shri Hathi):** (a) Yes, Sir. The Andhra Pradesh Government requested for an additional allotment of Rs. 2 crores for improvements to Kurnool-Cudappa Canal and Rs. 1.27 crores for the Rajolibunda Scheme.

(b) An additional provision of Rs. 74 lakhs (Rs. 40 lakhs for K.C. Canal and Rs. 34 lakhs for Rajolibunda) during 1958-59 has been agreed to by the Planning Commission, out of which Rs. 24 lakhs for the

Kurnool-Cudappa Canal and Rs. 20.4 lakhs for the Rajolibunda scheme will be the Central loan assistance provided the remaining amount is contributed by the State Government.

#### **Integral Coach Factory, Perambur**
