1874. SHRI TARIQ ANWAR:

SHRI BALASAHEB VIKHE PATIL:

Win the Minister of SHAPPING AND TRANSPORT be pleased to state:

- (b) whether these passes will be permanent basis:
- (c) whether this facility will be given under any Central Government scheme; and

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANS-PORT (SHRI SITARAM KÉSARI): (a) The D.T.C. has already started issuing free travel passes to disabled persons residing in the Union Territory of Delhi from 7th September, 1982 onwards.

- (b) Yes, Sir.
- (c) The facility has been extended on the basis of a decision taken by the D.T.C. with the prior approval of the Central Government.
- (d) Till 8th October, 1982, 783 such passes have been issued by the D.T.C.

Conversion of Viramgam-Okha-Porbander Line

- (c) what are the reasons for delaying the work of conversion upto Okha-Porbander;
- (d) what was the target fixed for the project and what was the amount estimated at that time; and
- (e) what will be cost of the project after completion?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMEN-TARY AFFAIRS (SHRI MALLIKAR-JUN): (a) The project was approved in 1972-73 budget.

Achievement of Target of Health for all by 2000

- (a) whether the World Health Organisation Regional Committee has urged member countries to take steps to define and implement their national plans of action to achieve the target of health for all by the year 2000;
- (b) details of points to be discussed by the regional committee; and
- (c) what steps have been taken by the Government to pursue the programme more vigorously?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHAN-KARANAND): (a) and (b). The progress of implementation of the national plans of Action to achieve the target of health for all by the year 2000 AD was discussed in the recently concluded meeting of the World Health Organisation, South-East Asia Regional Committee.

- (c) The Government of India have formulated a perspective Health Plan to achieve the goal of "Health for All by 2000 AD" The Plan provides for:-
 - (1) One Health Guide for every 1000 rural population by 31st March, 1984.
 - (2) At least one trained Dai for every village by 31st March, 1985.
 - (3) One Sub-Centre with one male and one female health worker for every 5000 population (for 3000 population in hilly and tribal areas) by 7th Five Year Plan (74 per cent during the 6th Plan period and the rest during the 7th Plan). 90,000 Sub-Centres are proposed to be established by the end of 6th Plan period.
 - (4) One Primary Health Centre for every 30,000 rural population (for 20,000 population in Hilly and tribal areas) by 2000 AD.
 - (5) One upgraded PHC/Community Health Centre for every one lakh rural population by 2000 AD.
