MOTIONS FOR ADJOURNMENT

FIRING ON SOME DISPLACED PERSONS IN MIKIR HILLS

Mr.Speaker: I have received notices of adjournment motions from Shri Hem Barua, Shri Banerjee, Shrimati Renu Chakravartty and Shri Elias and others relating to—

"The situation of grave anxiety and apprehension arising out of the police firing on a group of displaced persons in the Mikir Hills of Assam on the 8th March last, resulting in the death of two persons and injury to many others."

It is normally a State subject, being a matter of law and order. But as it refers to displaced persons, I would like to know what is the grievance and why it has occurred. What is the source of information of the hon. Members?

Shri Hem Barua (Gauhati): Sir, the police opened fire.....

Mr. Speaker: Order, order. What is the source of information?

Shri Hem Barua: It is a newspaper report, and I have received telegrams also from displaced persons. The police opened fire on the displaced persons on the 8th March and succeeded in killing 2 persons and injuring 4. The Government of Assam are engaged in evicting the displaced persons from the Mikir Hill area and that too by the use of elephants. They have employed elephants to destroy the hutments of these displaced persons.

I know how sensitive the tribal people are and I do not want any inroad to be made into their way of life, economically backward as they are. But, at the same time, we must not forget the fact that it is the Government that allowed these displaced persons to settle in that particular area---I mean the Mikir Hills area-when it constituted a part of the adjoining district of Nowgong.

Mr. Speaker: Let the hon. Member answer one of my questions. I am really considering whether this is not a tnatter which was raised by the hon. Member himself some time ago when the hon. Minister of Rehabilitation said that so far as the displaced persons were concerned every effort had been made to rehabilitate them elsewhere, but so far as others were concerned. they were coming ano
