(d) the reasons for the retention of services of the deputationists in the Town Planning Organisation?

The Minister of Health (Shri Karmarkar): (a) Twenty persons have been on deputation in the Town Planning Organisation from time to time since its inception.

- (b) So far thirteen persons have been reverted to their parent departments and only 7 are still on deputation in the Town Planning Organisation.
 - (c) Yes, only to a very small extent.
- (d) In view of the scarcity of experienced staff, it is necessary to retain the services of some deputationists in the interest of efficiency.
