### Handloom Industry in Andhra Pradesh

1614. Shri M. V. Krishna Rao: Will the Minister of Commerce and Indusbe pleased to state the amount of financial assistance asked for and proposed to be given from the handloom cess fund during 1960-61 towards the development of handloom industry in Andhra Pradesh?

The Minister of Commerce (Shri Kanungo): At a meeting held between the representatives of the State Government, Planning Commisson and this Ministry, it has been tentatively agreed that the ceiling of Central assistance to Andhra Pradesh for the development of handloom during 1960-61 will be Rs. 87:00 lakhs (Rs. 33.09 lakhs as loan and Rs. 53.91 lakhs as grant).

#### Industrial Estates in Andhra Pradesh

1615. Shri M. V. Krishna Rao: Will the Minister of Commerce and Industry be pleased to state the further progress since made in the different Industrial estates in Andhra Pradesh so far and the stages of their development?

The Minister of Industry (Shri Manubhai Shah): The progress made in the industrial estates in Andhra Pradesh is as follows:-

### (1) Industrial Estate at Sanatnagar

33 sheds have been completed and 30 of them have been allotted and occupied. 3 sheds have been retained for departmental units. 20 sheds have started functioning. 26 more sheds are under construction. 12 of them have their foundations ready. 2 have come up to truss level and 12 have trusses put and covered. Power supply is available in 25 sheds and water supply is available in all the 33 sheds completed. 8 units have reported production of the value of Rs. 1:62 lakhs. About 250 workers are reported to be employed in this estate.

# (2) Industrial Estate at Vijayawada

18 sheds have been completed and allotted. 11 of them have been occupied and 3 have started working. 4 more sheds are under construction. and two of them have their founds -tions ready and the other two have come upto plinth level. Power supply is available in 15 sheds. 3 units have reported monthly production of the value of Rs. 49,000. These units employ 52 persons.

## (3) Industrial Estate at Visakapatnam

27 sheds have been completed and allotted provisionally. 10 of have been occupied and one has started functioning. 4 more sheds are under construction and two of them have come up to window level and the other two upto truss level. Power supply is available in 13 sheds and water supply in 27 sheds.

#### Estate at Samalkot (4) Industrial

24 sheds have been completed and 14 allotted 8 have been occupied and 5 sheds occupied by 2 units have functioning. Water started Power Supply is available in 14 sheds.

The monthly production in the two industrial units occupying the 5 sheds is Rs. 20,300 and these units employ 47 persons.

#### (5) Industrial Estate at Nandval

10 sheds have been completed 7 of them have been allotted provisionally.

#### (6) Industrial Estate at Warangel

This Industrial estate has not yet been approved by the Government of India. However, it has been reported that 16 sheds in this estate have been
