addition to the usual export promotion measures such as participation in fairs and exhibitions, sponsoring of sales delegations, it is expected that export efforts of bicycles manufacturers will be strengthened by the various steps taken by the Government for supply of steel and pig iron on priority basis, supply of steel at international prices, simplification of import licencing procedures, advance licencing system for raw materials and introduction of 100% export oriented units.

EEPC recently organised the participation of six Indian firms in International Motor cycles and Cycle Fair, Cologne in September, 1982.

U. S. Arms Supply to Pakistan

- 6313. SHRI M. S. K. SATHIYEN-DRAN: Will the Minister of DEFENCE be pleased to state:
- (a) whether it is true that the United States of America has assured Pakistan of an additional 1.1 billion dollar military credit and expeditious supply of remaining F-16s; and
- (b) if so, what is the reaction of Government in this matter and the steps taken to cope with the situation?

THE MINISTER OF DEFENCE (SHRI R. VENKATARAMAN):

- (a) Government have no reliable information in this regard.
- (b) All developments affecting our security are assessed on a continuing basis and appropriate measures are initiated from time to time to maintain full defence preparedness.

Use of Army in Situation of Unrest

- 6314. SHRI BALASAHEB VIKHE PATIL: Will the Minister of DEFENCE be pleased to state:
- (a) whether it is a fact that in the past, the help of the Army was taken and is still now being taken in Assam to deal with a situation of unrest;
- (b) whether the Ministry has taken care to train some of the Army men for meeting such situations since it is not their normal function; and
- (c) whether the Army in the Eastern sector are briefed properly about the situation that they are required to handle so that their good image is not affected mainly because of lack of knowledge?

THE MINISTER OF DEFENCE (SHRI R. VENKATARAMAN):

(a) and (b) The Army has been providing various types of assistance to the State Government is Assam. Such assistance to civil authorities is a legitimate part of the Army's duties for which it is always kept trained.
