(b) if so, the details of the respective capacities laid down by the Vegetable Oil Products Control Order 1957 or any other such orders in respect of Margarine, Refined Oil and Industrial Hard Oils; and

(c) the actual production by Hindustan Lever Limited Ghaziabad of Vanaspati, Margarine, Refined Oil and Industrial Hard Oil respectively in the years 1974, 1975, 1976 and 1977?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD AND CIVIL SUP-(SHRI BHAGWAT JHA. PLIES AZAD): (a) and (b). While the Vegetable Oil Products (Standard of 1975. issued quality) Order. under the Vegetable Oil Products Control Order, 1947, does not lay down the extent to which M/s Hindustan Lever Limited or any vanaspati unit licensed/registered under the Industries (Development Regulation) Act. 1951, can produce & Margarine and Industrial Hard Oils for soap manufacture, the production of Refined Oils can be undertaken by such units to the extent of 25 per cent of their production of vanaspati during any calendar month under the Vegetable Oil Product Producers (Regulation of Refined Oil Manufacture) Order, 1973.

(c) The actual production of Vanaspati Margarine, Refined Oils and Industrial Hard Oils by M/s. Hindustan Lever Limited, Ghaziabad, for the year 1974 to 1977 is a_S under:
