#### Conversion Of Tiruvalla-Pathanamhitta-Punaloor Railway line

- 911. Prof. P. J. KURIEN: Will Minister of RAILWAYS pleased to state:
- (a) whether Government have received representation requesting for the construction of Tiruvalla, Pathanamthitta-Punaloor railway line and Chenganoor-Kottarakara Trivandrum railway line; and
- (b) if so, Government's reaction thereto?

THE MINISTER OF STATE THE MINISTRY OF RAILWAYS (SHRI C. K. JAFFER SHARIEF): (a) Yes.

(b) There is no proposal at present for construction of the above lines due to scarcity in resources position.

#### Bypassing of Malwan Port by Coastal Shipping Service between Bombay and Panaji

912. PROF. MADHU DANDAVATE: Will the Minister of SH PPING AND TRANSPORT be pleased to state:

- (a) whether it is a fact that the coastal shipping service from Bombay to Panaji bypasses the Malwan Port on the Konkan coast of Maharashtra;
  - (b) if so, the reasons thereof; and
- (c) whether expeditious steps will be taken to open the port Malwan to shipping services?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z. R. ANSARI): (a) Yes, Sir.

(b) The elimination of Malwan Port from the itinerary of passenger vessels was due to the Port being tidal and the number of vessels having been reduced from 5 to 2 in December 1972, when one of the vessels ran agreund at Malwan Port and was declared as a total loss. is not possible to call at Malwan and

yet maintain the punctuality of the service.

(c) The Mogul Line Limited do not propose to include Malwan Port in the itinerary of passenger vessels, as the two ships operated on this service cannot call at more than four ports due to constraints of their speed and the need to maintain the sailing schedules and punctuality in this service.

- I Resources for Renewals, replacements of Assets, Safety and Accidents Prevention.
- II Long term Perspectives on different aspects of Rail-borne Transportation.
- III Track, Bridges and Lands.
- IV Railway Reserve Fund.
- V Production and Maintenance of Rolling Stock.
- VI Fare and Freight Structure.
- (b) and (c) These parts of the Report are being processed by the Government and 94 recommendations have already been accepted fully or with modification.

#### Population of India and China

- (a) whether it is a fact that India is overtaking China in population;and
- (b) if so, the details and the present population of both the countries?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI MOHSINA KIDWAI): (a) No reliable information is available. However, based on whatever infor-

mation is thrown up in this regard, there is no likelihood of India overtaking China in population in near future.

(b) Population of India according to 1981 Census was 685 million and the population of China according to Census conducted in 1982 was 1032 million (including Taiwan Province).
