(ख) प्राकृतिक दुर्घटनाओं के असर को पूरी तौर पर दूर तो नहीं किया जा सकता, फिर भी जहां तक सम्भव हो सका है अधिक से अधिक लाइनों को जमीन के नीचे स्थानान्तरित करके उनका असर बहुत कुछ कम कर दिया गया है। इसके परिणामस्वरूप जब कि ५६-६० की सर्दियों में ६०० बार खराबियां हुई, ६०-६१ की सर्दियों के दौरान में केवल २०० बार खराबियां हुई, हालांकि उस वर्ष पहले से अधिक हिमपात हम्रा था।

Farakka Barrage

Will the Minister of Irrigation and Power be pleased to state:

- (a) whether it is a fact that the project for the construction of a barrage at Farakka is ready for implementation;
- (b) if so, whether any date is fixed from which the construction of the aforesaid barrage may begin; and
 - (c) the details of the project?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) Yes, the Project Report has been ready since April 1959, and detailed designs preceding construction have been under way.

- (b) The left afflux bund of the Farakka Barrage Project has been already completed. Further construction on major components of the project is proceeding.
- (c) The project envisages the construction of a barrage across the river Ganga at Farakka, a Feeder canal 26 miles long with its outfall into the river Bhagirathi and a Barrage at Jangipur below the outfall of the Feeder Canal.

The Deputy Minister of Agriculture (Shri A. M. (a) and (b). The vessel Portland Trader carrying a quantity of 9,800 long tons of wheat from U.S.A. was damaged in Sulu sea in the Philippines. It is estimated that the damaged quantity of wheat will not be more than 1,300 tons.

(c) The cargo was not insured with any Insurance Co., as the Government carry the insurable risk themselves.
