(c) and (d) Super Bazar generally procures napthalene balls from M/s Bengal Chemicals which is a reputed concern, manufacturing napthalene balls and other goods. As stock was not available with M/s Bengal Chemicals, Super Bazar procured its requirements from M/s Premier Dye Stuff Agency, Delhi, during the months of March. April and May, 1983. The Super Bazar has reported that inspection about its quality and genuineness was made by Purchase Manager on the spot, which was found to be satisfactory after visual inspection. The napthalenee balls presently on sale and purchase from the same party were also tested by Super Bazar Laboratory, located at Lady Irwin College, and found to be satisfactory.

सिचाई मन्त्रालय के राज्य मन्त्री (श्री राम निवास मिर्घा) : (क) माननीय सबस्य संभवतः नर्मदा घाटी विकास के प्रथम सोपान में मध्य प्रदेश सरकार द्वारा हाल ही में शरू की गई नर्मदा सागर परियोजना का उल्लेख कर रहे हैं। राज्य सरकार ने केन्द्रीय जल आयोग में तकनीकी जांच करने तथा योजना आयोग द्वारा स्वीकृति के लिए परियोजना रिपोर्ट प्रस्तुत नहीं की है। परियोजना के आवासीय तथा गैर-आवासीय भवनों, सडकों का मोडना. ड़िलिंग कार्य, खाइयों की खुढाई, शापट तथा एडिट जैसे पूर्व-निर्माण कार्य प्रगति पर हैं। बांध की नींव की खुदाई तथा व्यपवर्तन सुरंग के कार्य को चाल वित्तीय वर्ष में हाथ में लेने का प्रस्ताव है।

- (ख) परियोजना को 921 करोड़ रूपए की अनुमानित लागत की अपेक्षा अब तक लगभग 7 करोड़ रुपए व्यय किए जा चुके हैं।
- (ग) परियोजना को 1992 तक पूरा करने कालक्ष्य है।

## F. A. O. Specialist Group on Animal Breeding

1954. SHRI B. D. SINGH: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether Food and Agriculture Organisation of United Nations had constituted a specialist group to meet shortly on animal breeding and conveyed names of ICAR officers for participation therein;
- (b) the names of ICAR officers included in this group, its term of reference and scheduled date of first meeting;
- (c) whether the ICAR officials attended the first meeting and if not, the reasons therefor;
- (d) whether these ICAR officers have visited abroad during 1981, 1982 and in 1983, if so, the date-wise, place-wise details for each with purpose of visit and reasons for allowing them now, officer-wise; and
- (e) the details of rules/procedure ICAR follows on such international participations?

THE MINISTER OF AGRICULTURE (RAO BIRENDRA SINGH): (a) and (b) The FAO of the United Nations had consititued an FAO/UNEP Joint Panel of Experts on Animal Genetic Resources Conservation and Management. The first meeting of the Expert Panel was fixed for October 24-27, 1983. The list of Experts proposed by FAO to serve on the Panel in their personal capacity for a period of 4 years included the names of (i) Dr. R. M. Acharya, Deputy Director General (Animal Science), ICAR, and (ii) Dr. P. N. Bhat, Director, Central Institute for Research on Goats.

- (c) No, Sir. Due to some administrative reasons, these two officers could not be spared to accept the membership of the Panel. Consequently, they were not deputed to attend the first meeting of the Panel.
- (d) Yes, Sir. During 1981 and 1982, these two Officers were deputed abroad in

public interest. So far, they have not been deputed abroad during 1983. The details of their visits abroad during 1981 and 1982

are given in the enclosed statement.
