- (a) whether Government's attention has been drawn to 'Hindustan Times' dated 2 April, 1984 that Scientists at National Dairy Research Institute, Bangalore have developed a simple equipment which can efficiently convert milk into 'khoa' an important ingredient of Indian sweets; and
 - (b) if so, the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE: (SHRI YOGENDRA MAKWANA): (a) Yes, Sir.

(b) The Scientists of the National Dairy Research Institute, both at Karnal and Bangalore have developed an equipment which can convert milk into 'khoa'. The equipment is still in experimental stage.

Honorarium to Employees of Government of India Press

- (a) whether it is a fact that during IXth Asiad that held in Delhi in November, 1982, services of Government employees working in different Departments including the Government of India Press were utilised;

- (c) whether it is a fact that honorarium was sanctioned by Government to employees who were engaged in connection with the IXth Asiad:
- (d) if so, whether it is also a fact this honorarium was not disbursed to the employees of Government of India Press who were engaged in IXth Asiad; and
- (e) the reasons for discrimination being made with the Government Press employees?

THE DEPUTY MINISTER IN THE DEPARTMENT OF SPORTS (SHRI ASHOK GEHLOT): (a) Yes, Sir.

- (b) As per information furnished by Special Organising Committee, services of 2907 officials were utilised by it during IX Asiad. Out of this, 503 officials were inducted on foreign service terms and remaining 2399 were sanctioned out-of-pocket allowance.
- (c) and (d) In a few exceptional cases, the Special Organising Committee also sanctioned honorarium to serving officials, which included inter alia employees of the Government of India Press. So far as payment of honorarium to employees of Government of India Press is concerned, the amount was paid to General Manager, Government of India Press for disbursing to concerned officials.
