- (a) whether Russia, America, France, Canada and England have asked for the supply of thousands of models and articles prepared by taxidermy experts; and
- (b) if so, the steps taken by Government to supply those required articles and models?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A. C. GEORGE) (a) No, Sir.

# Permission to L. D. Cs. to Appear in L.D. Grade Eamingiton of U.P.S.C.

5479. SHRI C. P. SHAILANI: Will the PRIME MINISTER be pleased to state:

- (a) whether temporary, quasi-permanent and permanent L. D. Cs. of the Government of India are allowed to appear in the L. D. Grade Examination of the U. P. S. C. up to the age of 35 and if so, the reasons therefor;
- (b) whether some of L. D. C.s would have served the Government for 10-15 years before selection;
- (c) if so, whether their pay, seniority for accommodation and other benefits of their long service are protected;
- (d) whether such L. D. C,s if selected by the U.P.S.C., retain their seniority for further promotions also; and
- (e) if not, why other benefits are given to them and the reasons for allowing them to take U. P. S. C. examination up to the age of 35 years?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND IN THE DEPARTMENT OF PERSONNEL (SHRI RAM NIWAS MIRDHA) (a) to (e). The Second Pay Commission, while

considering the promotion prospects of L. D. C.s working in subordinate offices of the Central Government had inter alia recommended that they may be permitted to compete for appointment to L. D. Grade in the Secretariat by allowing them suitable age relaxation. The Government accepted the recommendation and L. D. C.s working in subordinate offices who have rendered at least 3 years service have been allowed age relaxation up to 35 years for appearing at the Clerks, Grade Examinations conducted by the Union Public Commission/Secretariat Service Training School for recruitment to L. D. Grade in the Secretariat from 1962 onwards.

Since these Lower Division Clerks can compete up to the age of 35 years, it is possible that some of them might have rendered 10-15 years of service. They do not suffer any financial loss because the last pay drawn by them in the subordinate offices is protected provided there is no break in their service. They are also entitled to Government accommodation on the basis of their dates of continuous employment under the Central Government.

They are, however, not entitled to count former service in subordinate offices towards seniority in L. D. Grade in the Secretariat. Their seniority is determined by the order of merit in which they are selected, persons appointed on the results of an earlier examination being senior to those appointed on the results of a subsequent examination.

### Market for Rubberised Coir Floormat for Automobiles

5480. SHRI C. JANARDHANAN: Will the Minister of FOREIGN TRADE be pleased to state whether Government have considered the possibility of developing a world market for rubberised coir floor-mat for automobiles under regular contract with car manufacturers of foreign countries?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A. C. GEORGE): The major automobile manufacturers have been contacted in this context, but they are not interested in a direct contract for the supply of coir car mates. The Government are, however, considering the possibility of developing a market for this commodity in West Europe.

#### Production of Rubber and its effect on Production of Auto Tyres and Tubes

5481. SHRI C. JANARDHANAN: Will the Minister of FOREIGN TRADE be pleased to state:

- (a) whether in the last five years the production of rubber has registered an increase; and
- (b) how has the increased production, if any, affected (i) the production of auto tyres and tubes (ii) import of raw rubber and (iii). prices of raw rubber?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A. C. GEORGE): (a) Yes, Sir.

(b) The increased production of rubber has led to (i) an increase in the production of auto tyres and tubes, (ii) discontinuance of the import of raw rubber since 1970-71, and (iii) price of raw rubber was fixed in September 1970 at Rs. 520/- R.M.A. Grade I per quintal nearest district Headquarters with suitable variations for other grades on the basis of recommendation of the Tariff Commission.
