Medical Adviser to the Indian High Commission for India in the U. K., to meet the Indian doctors and also to visit one or two hospitals there.

- (c) The expenditure incurred in Indian currency on the air travel of the members of the Delegation is Rs. 24,916/- approximately. The details of the foreign exchange expenditure incurred on hotel accommodation, daily allowance, entertainment etc. in respect of the Indian Delegation have not been received from the Indian Foreign Missions concerned.
- (d) India is a member of the World Health Organisation and in accordance with the Constitution of the World Health Organisation, a delegation is sent each year to participate in World Health Assembly meeting. The delegation participated in the general discussions held in the World Health Assembly, a supreme organ of the World Health Organisation. The probable aid that would be forthcoming to India from the World Health Organisation for its various operating Health Programmes is estimated to be \$ 623847 in 1971 and \$ 698302 in 1972.

- (b) if so, whether the Delhi Development Authority have since taken a decision to permit the allottees to cover the barsati on grounds of security; and
 - (c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (SHRI I. K. GUJRAL): (a) Yes, Sir.

(b) and (c). Not yet. The Authority is expected to take a decision soon.

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (SHRI I. K. GUJRAL): (a) Yes, Sir.
