Action against Employees in Default of E P F. in West Bengal

6658. SHRI JYOTIRMOY BOSU : Will the Minister of LABOUR AND REHABILITATION be pleased to state :

(a) whether some of the non-official members of the Provident Fund Board had demanded that the defaulting employers in West Bengal should be arrested;

(b) if so, the action taken on this demand; and

(c) the advice, if any, given by the Central Government to the State Government on this issue ?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI R. K. KHADILKAR) : (a) The Provident Fund Authorities have reported that no such demand has been made by non-official members of the Central Board of Trustees.

(c) The West Bengal Legislative Assembly is reported to have passed the Maintenance of Internal Security (West Bengal Amendment) Bill, 1972 which provides *inter-alia* for detention of employers who default in payment of E.P.F. dues.

Survey of Iron Pyrites at Saladipura, District Sikar (Rajasthan)

6659. SHRI SHIVNATH SINGH : Will the Minister of STEEL AND MINES be pleased to state :

(a) whether a survey of iron pyrites has been made at Saladipura in District Sikar of Rajasthan, and

(b) if so, the outcome thereof ?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI SHAHNAWAZ KHAN) : (a) and (b). The detailed exploration of Saladipura Pyrite-Pyrrhotite deposit in Sikar district of Rajasthan has been completed by the Geological Survey of India. Total indicated and inferred ore reserves of 43.36 million tonnes with 20 to 32 percent sulphur and 39.31 million tonnes with 11 to 16 percent sulphur have been estimated. Pyrites, Phosphates and Chemicals Limited, a Government of India Undertaking are taking steps for exploitation of the deposit.

Mineral deposits in Tamil Nadu

6660. SHRI M. RAJANGAM : Will the Minister of STEEL AND MINES be pleased to state :

(a) whether Government have under consideration a fresh programme for a Gamma Ray Spectrometer aerially, and not the EM systems, for locating new mineral resources in view of the non-conducting nature of the mineral deposits in Tamil Nadu; and

(b) if so, the main features thereof ?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI SHAHNAWAZ KHAN) : (a) No programme for Gamma Ray Spectrometer aerial survey in Tamil Nadu is under consideration of the Government of India.
