Demand for Theatres in the Country

3361. SHRI D. B. CHANDRA GOWDA : Will the Minister of INFORMATION AND BROADCASTING be pleased to state :

(a) whether there is a great demand for more theatres in the country ;

(b) if so, whether Government propose to build mini-theatres for the purpose ; and

(c) if so, the broad outlines of the proposals, state-wise ?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI DHARAM BIR SINHA) : (a) Yes, Sir.

One of the recommendations adopted at the Conference of the State Ministers of Information held in New Delhi on December 8, 1972, was that the States should divert a fixed proportion of collections from entertainment tax for promoting the construction of more cinemas.
