Indian Fertilizer Expert for Sudan

2220. SHRI LUTFUL HAQUE: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

- (a) whether the UNIDO has requested Government for any Indian Fertilizer expert for Sudan; and
- (b) whether Government have selected the expert and deputed him to Sudan on UNIDO assignment?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI DALBIR SINGH): (a) and (b). UNIDO had indicated to Government their intention to sponsor a particular Indian expert in the fertilizer field for an assignment in Sudan. However, the particular officer is not at present available for this assignment.

Damboroo Hydro-electric Project Schemes for Welfare of Displaced and Local Tribal People

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI BALGOVIND VERMA): (a) and (b) The scheme for the welfare of the displaced persons and the local Tribal people affected by the Damboroo Hydro Project in Tripura, is being implemented in phases.

(a) Government have yet to take a decision on the new synthetic drugs to be manufactured by Indian Drugs and Pharmaceuticals Ltd. during the 5th Five Year Plan and on the question whether new units should be set up for their manufacture.

- (c) whether, in the backward areas of West Bengal where child marriages are on the increase. Government propose to conduct a survey?
