Finished Steel Pile up with various Plants

578. SHRI S. A. MURUGANAN-THAM: Will the Minister of STEEL. AND MINES be pleased to state:

- (a) whether about 3,00,000 tonnes of finished steel have piled up at various plants and stockyards for which there is no buyer and SAIL has been exploring poss bilities of exporting them; and
 - (b) if so, broad outlines of the fact?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND MINES (SHRI SUKHDEV PRASAD): (a) and (b). About a months' production i.e. about 3 lakh tonnes of finished steel is lying at various plants and stock-yards. There is no difficulty in selling finished steel items except bars, where the demand has come down. Arrangements are being made to export surplus bars.

Traffic handling by Paradip Port

580. SHRI S. R. DAMANI: Will the Minister of SHIPPING AND TRANS-PORT be pleased to state.

- (a) whether Paradip Port is running into difficulties after its good record of handling traffic of 2.74 lakh tonnes in March last year;
- (b) if so, the reasons thereof including the responsibility of MMTC and the Railways; and
- (c) the steps taken to bring about coordination among all concεrned to make the fullest use of this deep-draft port?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI H M. TRI-VEDI): (a) to (c). Under-utilisation of the Port's capacity results in losses to the Paradip Port. Problems relating to the movement of iron ore from the port are taken up with MMTC and the Railways from time to time. A meeting was convened in the Ministry on 19th August, 1974 to discuss the question of effective coordination between the Railways, MMTC and the Port Trust. At an inter-Ministerial meeting held in the Ministry on 8th November, 1974 the representatives of Railways MMTC agreed that handling of iron ore would be geared up to make up for the shortfall in the current year to the maximum extent possible.
