THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI K. R. GANESH):

(a) and (b, M|s. Hindustan Lever Ltd., have been issued two letters of intent and not industrial licence for setting up new units at Haldia for the manufacture of the undermentioned items for the capacities shown against each,

Crisis faced by Drugs and Pharmaceutical firms of West Bengal

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI K. R. GANESH):
(a) to (c). All India Manufacturers Organisation has submitted a memorandum to the Committee on Drugs and Pharmaceutical Industry high lighting the problems like supply of raw materials, shortage of electric power and, gas, financial constraints need for establishment of basic chemicals infrastructure etc. relating to drug units in the Eastern Region. The Committee is expected to submit its report by April, 1975.

In addition complaints requests for assistance in the nature of shortage of raw materials, financial difficulties, uneconomical production, power shortage etc. have also been received from certain units.
