**Trespass by Pakistanis into Rajasthan**

**The Prime Minister and Minister of External Affairs, Defence and Atomic Energy (Shri Jawaharlal**

**Nehru):** (a) and (b). On the night of October 2-3, 1962 four Pakistani criminals burgled the shops of two Indian nationals of village Sattasar, P.S. Pugal, Bikaner and carried away cash, jewellery and other articles worth about Rs. 5,000 and a camel worth about Rs. 400. The Indian Border Police has supplied clues, particulars etc. to the Pakistani Border Police which may help in tracing the burglars.

**Firing by Pak Troops near Jammu**

Will the **Prime Minister** be pleased to state:

(a) whether it is a fact that unprovoked firing was resorted to by the Pakistani forces in the Akhnoor area near Jammu on the 6th October, 1962;

(b) if so, whether any protest has been lodged with Pakistan;

(c) the details of the reply received from them; and

(d) the number of casualties suffered due to this firing?

**The Prime Minister and Minister of External Affairs, Defence and Atomic Energy (Shri Jawaharlal Nehru):** (a) On October 6, 1962, at 1645 hours PAK/POK troops fired 18 rifle shots towards our Pirjamal Post, 4 miles west of Chhamb. Our police had to return the fire in self-defence. A cease-fire violation complaint was lodged with the U.N. Military Observers whose award is awaited.

(c) Does not arise.

(d) No casualty has been reported.
