THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHD. SHAFI QURESHI): (a) Yes, Sir

- (b) Letters of Intent/Licences have already been issued under the Industries (Development & Rehabilitation) Act in favour of 13 units for importing machinery subject to certain conditions and for establishing industrial undertakings for the production of machine made carpets.
- (c) The following steps have been taken by Government:
 - (i) The foreign exchange allocation for import of raw wool which is required by the worsted sector of the industry was increased from Rs. 2 crore in 1965-66 to Rs. 12 crore in 1966-67. The same level of allotment is being maintained for the half year October 1967 to March 1968.
 - (ii) The policy for Registered Exporters provides for import replenishment to manufacturer—exporters in respect of woollen prices and hosiery exported by them.
 - (iii) Modernisation of machinery is encouraged.
 - (iv) Greater use of indigenous wool with a view to increase production of woollen goods is encouraged.
 - (v) Greater attention is paid to improve the quality and yield of wool.

No. The correct position is that two consignments booked from Sitamarhi to Chitpur were fraudulently diverted to Manpur by changing the seal cards and delivered on production of a forged Railway Receipt. Two persons have been arrested by Government Railway Police, Gaya in this connection. The amount involved is Rs. 50,000 and not Rs. 50,00,000|-
