University Centre at Sambalpur, Orissa

Will the Minister of Education be pleased to state:

(a) whether it has been decided to open one University Centre at Sambalpur, Orissa;

(b) if so, the functions of the proposed Centre and how it differ from the University; and

(c) whether there was a unanimous demand by all sections in that area to establish a University at Sambalpur and whether all the criteria have been satisfied?

The Minister of Education (Shri M. C. Chagla): (a) to (c). The State Government had made a request to the Union Education Minister for establishing two new Universities at Sambalpur and Berhampore and he had advised them to set up instead two university centres at these places. No decision has yet been taken on this issue.

Collection for N.D.F. in Delhi Schools

Will the Minister of Education be pleased to state:

(a) whether it is a fact that many schools in Delhi/New Delhi have collected subscriptions for the National Defence Fund from the students without issuing proper receipts to them;

(b) if so, the names of those schools and the reasons therefor;

(c) how the amount thus collected was assessed to be all correct and without any mis-appropriation; and

(d) the action Government has taken or propose to take not to allow any institution or individual in future to collect the subscription to the National Defence Fund or any other fund on Government account without issuing a proper receipt for the actual amount or material received?

The Minister of Education (Shri M. C. Chagla): (a) to (d). The requisite information is being collected and will be laid on the Table of the Sabha in due course.

Illiterates in India

2108. Shri Muthiah: Will the Minister of Education be pleased to state:

(a) whether it is a fact that India has the largest number of illiterate people in the world;

(b) if so, the number of illiterate people in the country at present;

(c) the *per capita* annual expenditure on Education in India; and

(d) whether India's expenditure on research is the lowest?

The Deputy Minister in the Ministry of Education (Shrimati Soundaram Ramachandran): (a) The latest figures in respect of China are not available and therefore a specific answer is not possible. In 1951, the number of illiterates in China was the largest in the world.

(b) The total number of illiterate people in India, according to the census of 1961, is 33,39,01,801.

(c) It was Rs. 7.8 in 1961.

(d) The information is not available.

Fertilizer Project at Visakhapatnam

2109. Shri P. C. Boroah: Will the Minister of Petroleum and Chemicals be pleased to state:

(a) the progress so far made in the implementation of the U.S. aided Coromandel Fertilizers project at Visakhapatnam;

(b) the expenditure incurred thereon so far; and

(c) when it is likely to be completed?

The Minister of State in the Ministry of Petroleum and Chemicals (Shri Alagesan): (a) Construction work on the project was started in February, 1965. About 10 per cent of the materials have arrived at site from U.S.A. and from within the country. Further shipment of machinery and equipment is expected to arrive in December, 1965.

(b) Rs. 5.73 crores upto September, 1965.

(c) End of 1966.

Fertilizer Plant in Assam

(a) the quantity of natural gas proposed to be utilised by the contemplated fertilizer plant in Assam;

(c) where it is proposed to be set up and what are its other broad features?
