

Recruitment of Scheduled Castes and Scheduled Tribes in Services

3501. SHRI SIDDAYYA : Will the Minister of HOME AFFAIRS be pleased refer to the reply given to Unstarred Question No. 2428 on the 2nd August, 1968 and state :

(a) whether any state Government has set up a High Power Committee to review the performance in the matter of recruitment of the Scheduled Castes and Scheduled Tribes in the services as recommended by the Yardi group;

(b) if so, the details thereof; and

(c) if not, the reasons therefor ?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI K. S. RAMASWAMY) : (a) The replies from State Governments, who were requested to consider formation of Committees similar to that of the High Power Committee set up at the Centre, are still awaited.

(b) and (c). Do not arise.

Hindi Sahitya Sammelan, Prayag

3502. SHRI HEM RAJ : Will the Minister of EDUCATION be pleased to state :

(a) the work that has been done by the Hindi Sahitya Sammelan, Prayag during the years 1963 to 1968 to date;

(b) what are its subsidiary bodies and the amount of control exercised by it on them;

(c) whether it is a fact that the Rashtra Bhasha Prachar Samiti, Wardha is working independently for the propagation of Hindi;

(d) whether it is also a fact that the Hindi Sahitya Sammelan, Prayag is a stumbling block in the work being done by the Samiti; and

(e) if so, whether Government propose to accept the independent entity of the Rashtra Bhasha Samiti, Wardha and give it proper help for the propagation of Hindi ?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SHRI SHER SINGH) : (a). During the period in question, the Hindi Sahitya Sammelan,

Prayag continued its normal literary activities and conduct of various Hindi examinations. Among other things, the Sammelan published 47 books on Hindi literature, brought out reprints of 64 Hindi books, published its Research Journal "Sammelan Patrika", literary monthly magazine "Madhyam" and weekly "Rashtra Bhasha Sandesh". The Sangrahalaya compiled 3,500 rare Hindi manuscripts, edited and published 11 of them. The Sammelan also rendered financial assistance to about 28 Hindi Organisations and organised various literary functions from time to time.

(b) There are no subsidiary bodies of the Sammelan. But there are institutions in almost all the states and Union Territories which have been elected as members of the Sammelan.

(c) and (d). According to Sammelan Niyamavali, the Rashtra Bhasha Prachar Samiti, Wardha are free to conduct its own affairs and lay down procedure thereof subject to the provision of Hindi Sahitya Sammelan Act and Rules framed thereunder and the direction given by the Governing Body of the Sammelan from time to time. There were some recent reports about differences of opinion between the Samiti and the Sammelan. It is understood that these differences are being amicably settled.

(e) The question at present does not arise.
